Notification of the Drafting Committee of Assam State Rules for the Juvenile Justice (Care and Protection of Children) Act, 2015-

1. The Juvenile Justice (Care and Protection of Children) Act, 2015 (hereafter, referred as JJ Act 2015) came into force on 15 January 2016, vide, S.O.110(E), dated 12th January, 2016, published in the Gazette of India, Extra., Pt.II, sec.3(ii), No. 96, dated 13th January, 2016.
2. As per the Section 111 of the said Act, The Juvenile Justice (Care and Protection of Children) Act, 2000 was thereby repealed.
3. As mandated under section 110 (1) of JJ Act, 2015, the State Government shall, by notification in the Official Gazette, make rules to carry out the purposes of this Act.
4. Wherein, the Ministry of Women and Child Development (MWCD), Government of India, vide G.S.R. 898, dated 21 September 2016 has notified the model rules for JJ Act 2015 in exercise of the powers conferred by the proviso to sub-section (1) of section 110.

The following criterion will be adhered to in the functioning of the Drafting Committee:

- a) The first meeting of the Committee should be held within 7 (Seven) working days of **notification of the Drafting Committee by the Government;**
- b) The Committee shall meet as and when the Chairperson convenes the meeting in due consultation with the Convener and with at least a notice of 2 (two) working days to all the Members of the Drafting Committee;
- c) The Drafting Committee will finalize the State Rules and forward the same to the Principal Secretary, Department of Social Welfare, Government of Assam through proper channel, for consideration and notification by Government of Assam;
- d) The Drafting Committee will consult and seek comments/ feedback through various means and methods (including over available IT platforms) with expressed deadlines from key stakeholders and duty bearers of the Child Protection/ Juvenile Justice system in Assam on the draft State Rules once framed by the Drafting Committee;
- e) The Drafting Committee will discuss on those comments and feedback received from key stakeholders and decide (based on the concurrence of the majority voting Members) the inclusion of the same in the State Rules;
- f) The Drafting Committee will submit the finalized draft of the Assam State Rules for JJ Act 2015 within 3 (Three) calendar months of the first meeting of the Drafting Committee.
- g) For any meeting to be held, the participation of 50% or more of the Members (excluding the Non- Voting Member) of the Drafting Committee (including the Chairperson and the Convener) will be compulsory to maintain quorum of the Committee.

TRANSFER POLICY

No. HC.VII-197/2013/4972-4992/A.-

In partial modification of earlier Transfer Policy of Judicial Officers of Assam issued under Memo No.HC.VII-197/2013/1652-1673/A, dated 13.03.2015, the following Transfer Policy of Judicial Officers of Assam is adopted:

1. This policy shall be known as transfer policy of Judicial Officers in the State of Assam.
2. Transfer being an incidence of service, the Judicial Officers shall be liable to transfer from one station to another on routine as well as on the basis of exigency of service.
3. For the purpose of transfer and posting, the entire State of Assam is divided into 7(seven) zones comprising of some districts and the same are as follows:

| ZONE- B | Bongaigaon, Dhubri, Barpeta, Goalpara |

| ZONE- E | Nagaon, Golaghat, Karbi Anglong, Dima Hasao |
| ZONE- F | Cachar, Karimganj, Hailakandi |
| ZONE- G | Jorhat, Sivasagar, Dibrugarh, Tinsukia |

4. **Transfer from one zone to another will be on rotation basis. As such, all officers shall have to serve in all the zones during their tenure of service.**
5. **The normal tenure in one zone shall be of 3(three) years from the date of joining at a station irrespective of whether the officer gets promotion or not to the next higher post. However, an officer may file representation for extension of tenure at a place beyond 3(three) years or for transfer before expiry of such period of 3(three) years. In either case such representation shall be examined and decided by High Court on merit. In the event an officer is promoted within the normal tenure of 3(three) years to the next higher grade, effort shall be made to keep him in the same zone. However, if any exigency arises and there is no vacancy in the zone, in that event he may be transferred out of the zone on promotion.**
6. **Annual transfer of Judicial Officers shall be made in the month of December and March, every year and in the month of October, Officers may submit option in the Form, attached herewith, to the High Court, in the case of those who complete 3 (three) years, in December and March indicating 3(three) places of choice with reasons for choosing the places and in case of others, who desire transfer before completion of the aforesaid period indicating request for transfer 3(three) places of their choice. However, it is made clear that the High Court, in the interest of administration of public interest transfer any Officer to any station of the aforesaid zones.**
7. **Ordinarily an officer posted in 1(one) zone would not be considered for posting in the same zone till he has been posted in all other zones.**
8. **An officer on completion of total length of service of 12(twelve) years irrespective of his grade may ask for choice posting in any district which shall be considered on overall length of service subject to availability of vacancy and exigency of service.**
9. **While considering such choice posting the period of service of the officer left for retirement would also be considered. Such choice posting can be availed only once in the entire service period.**
10. **As far as possible the last posting of an officer, before retirement, should be in the district of which he is a permanent resident or a district of his choice.**
11. **If in a particular grade in a particular zone, sufficient posts are not available, the officer on transfer on completion of normal tenure may be accommodated in another zone.**
12. **Judicial Officers should work in both civil and criminal side.**
13. **No officer shall be posted within a period of 10(ten)years from the date of his initial appointment in a station which falls in his home district or where he had occasion to work as an Advocate on regular basis.**
14. **Where both husband and wife are Judicial Officers, effort shall be made first to post them in the same station, if not possible, in the same district and if that is also not possible, in the same zone, subject, however to the condition that one of the officers should not be the Reporting or Reviewing Authority of the ACR in respect of the other officer.**
15. **If an officer or any of his near relations (parents, spouse & children)and parents-in-laws incase of lady Judicial Officers are suffering from terminal illness such as cancer, kidney failure etc. he shall he entitled to preferential treatment for posting in a place where proper treatment facilities are available.**

16. Judicial Officer with physical disability of 40% other than visual or hearing shall be entitled to posting in such places where frequent travels or mobility for long period is not required.
17. In stations like Chapakhowa, Jonal, Dhakuakhana, Majuli, Dhansiri, Chirang, Baksa, Diphu, Haflong, Gossaigaon and Hatsingimari, the normal tenure shall be 1(one) year and thereafter remaining two years may be in the same zone in the stations other than the above specified stations or any other zone.
18. The Judicial Officers of Assam shall not make transfer request on frivolous grounds and such request for transfer can only be made when there are genuine grounds, supported by genuine circumstances and corroborated by tenable materials. Otherwise, they will risk disciplinary action.
19. Judicial Officers who is transferred at his own request is not entitled to travelling allowance in the spirit of SR 241 in Division XII of the Fundamental Rules and Subsidiary Rules.
20. The Hon'ble Chief Justice, however, shall have the power to relax and /or to dispense with any of the foregoing provisions, if exigency of service so requires.
21. In case of any doubt or confusion in regard to purport, meaning or application of any of the aforesaid provisions, the decision of the Hon'ble Chief Justice shall be final.

Lett. No. PG. 22/70/P-II/1, dated Shillong, the 2nd June, 1970 from the Chief Secretary to the Government of Assam to all Administrative Departments, all Head of Departments, All Deputy Commissioners and Subdivisional Officers.

SUBJECT :- Timely publication of Government Notifications and other important matters in the weekly Official Gazette.

I am directed to say that it has come to the notice of Government that important notification having bearing on statutes and matters of immediate public interest are sometimes published in the Official Gazette on date much later than prescribed. Government have decided, therefore, to introduce the following system with immediate effect, which must be strictl adhered to in sending notice to the Assam Government Press for publication in the official Gazette.

1. In the first instance, it has to be noted that the printing of the weekly Gazette must be completed by the end of every Tuesday so that it may be duly published on every Wednesday.

2. Every notification and every other matter which is required to be printed and published in a particular issue of the Official Gazette must, therefore, reach the Deputy Director, Assam Government Press on the Monday of the week preceding the week in which it is required to be published. If this is not done it is infructuous requesting the Deputy Director, Assam Government Press to publish such notification or other matter in the next issue of the Gazette, the expression usually inserted in all endorsements made to the Deputy Director.

3. Wherever it is necessary to print and publish a notification on a specified date (excluding such Notification or communicate as are to be published in Gazette extraordinary) clear instruction of that effect must be given to the Deputy Director, Assam Government Press, both on the body of such notification within the indication at the top in the red ink and is a separate covering.

4. To achieve the objective in papers 2 and 3, it is essential that proper discretion should be exercised by the concerned officers in the Department or office and all matters for publication in the Gazette should scrutinised and sent to the Press after careful application.

5. As for publication of any matters in a Gazette, Extraordinary, the existing procedure whereby the prior approval of the General Administration Department is to be obtained will continue.
