Thakur filed a Writ Petition before the Hon'ble High Court vide WP(C) No. 2694/2016.

Whereas, the order from Hon'ble Gauhati High Court dated 12-08-2016 in the WP(C) No. 2694/2016 states that :-

"A perusal of the transfer order issued vide Notification dated 11-03-2016 also clearly shows that the transfer has been made in pursuance of the guidelines of the Election Commission of India. It, thus, shows that the transfer was not made in the normal exigencies of service. It was neither a routine transfer, but made only for the purpose of ensuing election. As the elections are over, the State Government has to take a decision with regard to the posting of the petitioner as the very basis of the notification dated 11-03-2016 has become infructuous. Accordingly, in view of the reasons stated above, the State respondents, especially the respondent No. 1 & 3, are directed to examine whether the petitioner's transfer by way of the impugned notification dated 11-03-2006 is to be cancelled or retained and take a decision thereon by a speaking order within a period of one month from the date of receipt of a certified copy of this order."

Whereas, it is felt that the order dated 11-03-2016 was purely in pursuance of the guidelines of Election Commission of India, and now it has lost further relevance.

In view of the above, the Notification dated 11-03-2016 in respect of transfer of Shri B.K. Thakur, Labour Inspector, Tinsukia placed in Sl.- No.-5 of Labour Inspector category hereby stands cancelled.
