Whereas the Deputy Commissioner, Darrang Mangaldai submitted one report Vide No. DDP/CDPO(ICDS)/168/2017/215, dated 8th November/2017 wherein it was stated that AWW & AWH association under Sipajhar ICDS has been resorting to agitational programmes like Dharna, Gherao etc against Sri Balendra Nath Barman which has become a concern for the District Administration. The Deputy Commissioner has recommended to take stern departmental action against Sri Barman.

Whereas Shri Barman submitted petition to the Govt. stating he has been engaged as LRCR under NRC. This Department vide letter No. SWD.477/2010/78, dated 11/09/2017 had requested State Coordinator, NRC, Assam to release the concerned officer from NRC duty immediately. On this the NRC Authority informed that if a suitable officer is posted, Shri Barman may be released.

It is also carefully noted that the alleged illegal activities of the officer has resulted in a law & order situation thereby placing the District Administration in an embarrassing situation.

Therefore, it has become necessary to initiate action against the officer concerned.
