#### ORDER OF SUSPENSION

No. GSA. 21/2010/Pt. 1.- Whereas, the Dibrugarh Police while conducting investigation in connection with the Dibrugarh Police Case No. 936/2016 has found several incriminating evidences against Dr. Samedur Rahman, Member, Assam Public Service Commission as reported by Police regarding his involvement in carrying out criminal activities to recruit people to Government services for which examinations were conducted in the APSC. Accordingly, Dr. Rahman was also arrested on 09/11/2016 in connection with the case No. 936/2016 under Section 7/13(1) (b) (2) (d) of Prevention of Corruption Act.

Whereas, as per Police Report, during the interrogation, based on the main accused Shri Nabakanta Patir's statement, the link of Dr. Samedur Rahman was established to this conspiracy.

Whereas the accused Shri Patir admitted that he used to collect the names and roll numbers of the candidates along with their mobile numbers, who are willing to pay money for the government jobs for which they have appeared at the interview or examinations conducted by the APSC and send the same to Dr. Samedur Rahman Member, APSC, Shri Patir also admitted to have paid money on several occasions to Dr. Samedur Rahman in his Rangiya residence in presence of Md. Mabud Ali Choudhury the PSO of Dr.Samedur Rahman.

Whereas, Md. Mabud Ali Choudhury, the PSO of Dr. Samedur Rahman was arrested on 30-10-2016 in connection with the same case, the Police Report reveals that during the interrogation Sri Mabud made statement regarding the involvement of Dr. Samedur Rahman in this case as he used to liaise with the agents and candidates for receiving money on behalf of Dr. Samedur Rahman. He also made statement that he used to handover money collected from candidates in exchange of jobs to Dr. Samedur Rahman and sometimes Nabakanta Patir also used to deliver money collected in the similar manner to Dr. Samedur Rahman.

Whereas, Shri Pabitra Koibortta, Assistant Controller, APSC and another accused person who was arrested in this case on 11-11-2016 also reveals the involvement of Dr. Samedur Rahman in the case while giving statement to Police. Police Report shows that Sri Kaibortta made statement to the extent that he in collusion with Dr. Samedur Rahman, Sri Rakesh Kumar Paul and others carried out the activities of giving jobs through APSC in consideration of money.

Whereas, Dr. Samedur Rahman revealed during his interrogation that he had received an amount of Rs. 10 lakhs from a candidate for a job. He led the investigating team on 17-11-2016 to show the concealed amount in his residence. Subsequently, under the provision of Sec 27 of Indian Evidence Act, a search team was sent to conduct an enquiry which recovered an amount of Rs. 9.5 lakhs from his residence located at Guwahati.

Whereas, the arrested accused Dr. Samedur Rahman was produced before the Hon'ble Special Judge, Guwahati Assam and the Hon'ble judge was pleased to state in his order dtd. 09/11/2016 that "considering the entire facts and circumstances in the light of materials available with the C/D, I found ground to allow the I/O of this case to take the accused in his custody" and accordingly the Special Judge allowed 14 days' Police custody of the accused. On being completion of his police remand, the accused was produced before the Special Judge, Guwahati who was remanded to judicial custody for six days.

Whereas, presently Sri Samedur Rahman is in judicial custody after completion of his police remand.

Whereas, in view of the above, I have made a reference to the Hon'ble President of India under clause (1) of Article 317 of the Constitution for inquiry and report.

Now, therefore, in the above circumstances, Sri Samedur Rahman is hereby placed under suspension with immediate effect till the time order is passed by the Hon'ble President of India, on receipt of the report of the Hon'ble Supreme Court of India on the reference made to the Hon'ble Court as per provisions of Clause (2) of Article 317 of the Constitution.

#### ORDER OF SUSPENSION

No. GSA. 21/2010/Pt.1.-Whereas, the Dibrugarh Police while conducting investigation in connection with the Dibrugarh Police Case No. 936/2016 has found several incriminating evidences against Dr. Basanta Kumar Doley in the illegal recruitment under APSC and accordingly he was also arrested on 28-11-2016.

Whereas, as per Police Report, during the interrogation, based Shri Rakesh Kumar Paul's statement, the link of Dr. Basanta Kumar Doley was established to this conspiracy. The accused Shri Rakesh Kumar Paul admitted that Dr. Basanta Kumar Doley is involved in almost all illegal activities relating to selection for posts by APSC especially in direct recruitment cases.

Whereas, Police Report also reveals that Dr. Samedur Rahman also made statement regarding Dr. Basanta Kumar Doley's involvement in the illegal selection through APSC

Whereas, Police Report mentions about the Statement of one Shri Biswajyoti Nath, S/O Mahendra Nath of Barpeta who stated that one Shri Abbas Ali Ahmed, an employee of APSC told him over phone that if he paid Rs. 15.00 Lakhs he would be given the post of District Malaria Officer. Sri Abbas Ali Ahmed told him that he has good relation with Dr. Samedur Rahman and Dr. Basanta Kumar Doley and he has to pay the amount to them. As per Police report, the statement of Abbas Ali Ahmed has corroborated the Statement of Biswajyoti Nath. In his statement Shri Abbas Ali Ahmed also stated that he used to collect the contact details of such candidates who were to appear for interview in the APSC and used to approach such candidates as per direction of Dr. Basanta Kumar Doley and Dr. Samedur Rahman.

Whereas, the police investigation report also reveals that Dr. Basant Kumar Doley has destroyed certain papers / documents of APSC on 06-11-2016 after arrest of Shri Rakesh Kumar Paul, Chairman, APSC. The documents were destroyed without following proper office procedure. Police has collected the remnants of the burned documents which is being sent to Forensic Laboratory for testing.

Whereas, the Police Report reveals that from the rented house of Dr. Basanta Kumar Doley located near Sankardev Kalakhetra while conducting searching operation, police recovered 26 copies of admit cards of different candidates appearing for APSC examination and 13 Nos. small sheets containing names and / or Roll Nos. of candidates.

Whereas, Police also seized one laptop and 6 Nos, of pen drives from the rented house of Dr. Basanta Kumar Doley on 03-12-2016 which are being sent to Forensic laboratory for examination.

Whereas, the arrested accused Dr. Basanta Kumar Doley was produced before the Hon'ble Special Judge, Guwahati, Assam and the Hon'ble Judge was pleased to state in his order dtd. 29/11/2016 that "the materials so far surfaced in the C/D against the accused is sufficient to remand the accused Dr. Basanta Kumar Doley in the Police custody" and therefore, the accused was remanded to police custody for a period of fourteen days.

Whereas, presently, Dr. Basanta Kumar Doley is in judicial custody after completion of his police remand.

Whereas, in view of the above, I have made a reference to the Hon'ble President of India under clause (1) of Article 317 of the Constitution for inquiry and report.

Now, therefore, in the above circumstances, Dr. Basanta Kumar Doley is hereby placed under suspension with immediate effect till the time order is passed by the Hon'ble President of India, on receipt of the report of the Hon'ble Supreme Court of India on the reference made to the Hon'ble Court as per provisions of Clause (2) of Article 317 of the Constitution.
