No. BB. 178/2005/52.-The Governor of Assam is pleased to order the establishment of a Banking District Treasury at Mushalpur Headquarter in Baksa District and to authorize the said District Treasury to conduct Government Business with the State Bank of India Branch at Mushalpur subject to observance of Treasury Rules & Subsidiary Orders and laid procedures. The territorial jurisdiction of the Treasury will cover the areas of Mushalpur Headquarter notified vide Government Notification No. GAG (B).137/2002/Pt./117, dated 30th October, 2003.

The Head Quarter of the District Treasury will be at Mushalpur. The District Treasury will start transacting Government Business with effect from **1st April, 2017** and compilation etc. of the District Treasury accounts will start from the same month. The monthly accounts of the Mushalpur District Treasury shall be closed on the last working day of the calendar month. The District Treasury will submit its monthly accounts directly to the Accountant General (A & E), Assam, Guwahati. The procedures and instructions laid down in the Treasury Rules & Subsidiary Orders, Assam Financial Rules, Account Codes and other relevant rules and orders in regard to receipt, custody and payment of money, custody of treasures, security arrangements, conduct of business, maintenance and submission of accounts at District Treasury will be generally applicable to Mushalpur District Treasury.

The District Treasury should be annually inspected by the Deputy Commissioner of the district in addition to the periodic inspection to be done by the Commissioner, Lower Assam Division in order to ensure proper management and administration.

The provision in the Accounts Code Volume- II, Standing Orders, in regard to (i) classification of transactions occurring in the District Treasury (ii) general direction regarding accounts to be kept at District Treasury and (iii) the accounts on return to be submitted to the Accountant General (A & E), Assam shall be strictly followed.

ORDER

No. GLR. 463/90/233 .- Whereas, Shri Bimal Kr. Baruah, Labour Inspector, Mazbat (U/S) has been placed under suspension vide Notification No. GLR.463/90/128, dated 26-08-2015 in view of the report of non-performing and dereliction of duty as submitted by the Labour Commissioner, Assam. And whereas, a Show Cause Notice has been issued to Shri Bimal Kr. Baruah, Labour Inspector (U/S) vide letter No. GLR.463/90/139, dated 28-12-2015 directing him to submit his reply.

As per Statement of allegation it is found that Shri Bimal Kr. Baruah was entrusted with the responsibility of inspection of 8(eight) nos. of tea gardens within Udalguri Sub-Division and submit inspection report in respect of the said tea gardens and to take follow up action as required under Plantation Labour Act, 1951 as amended and the rules framed there under. But as per the record of the Asstt. Labour Commissioner, Dhubri, Assam it was found that Shri Bimal Kr. Baruah neither inspected a single tea estate during his tenure nor submitted any inspection report either to the tea garden management or to the Chief Inspector of Plantations, Assam. In spite of specific instruction from the Asstt. Labour Commissioner, Dhubri also, Shri Baruah has failed to carry out responsibilities in utter disobedience of orders issued by statutory authorities. These discrepancies have been witnessed by the two officials under Labour Commissioner namely :

1. Shri M. Rahman, Asstt. Labour Commissioner, Guwahati and the then Asstt. Labour Commissioner, Dhubri and
2. Shri Dhiren Goswami, Retd. the then Deputy Labour Commissioner-cum-Chief Inspector of Plantation, Assam.

Although, Shri Bimal Kr. Baruah was responsible for enforcement of the provisions of the act, and the Rules made there under in the tea plantations allotted to him, but he did nothing for enforcement of the Acts & Rules.

And whereas, Shri Bimal Kr. Baruah has submitted his reply vide letter dated 30-01-2016 by denying the charges framed against him.

And whereas, after examination of the reply furnished by the officer, it is decided to initiate departmental Proceeding against Shri Bimal Kr. Baruah, Labour Inspector, under the Assam Service (Discipline & Appeal) Rules, 1964.

And whereas, under provision of Sub Rule 4 of Rule 9 of the Assam Services (Discipline and Appeal) Rules, 1964, the Governor of Assam is pleased to appoint Shri Omar Ali Badshah, ACS., Deputy Secy. to the Govt. of Assam, Labour & Welfare Department & Skill, Employment & Entrepreneurship Department as Inquiry Officer to enquire into the charges leveled against Shri Bimal Kr. Baruah, Labour Inspector, Mazbat (U/S) and submit Inquiry report/findings to the Government.

Further Under provision of Sub-Rule 5 of Rule 9 of the Assam Service (Discipline and Appeal) Rules, 1964, the Governor of Assam is pleased to nominate Smt. K. - (i) The Sponsorship and Foster Care Approval Committee shall coordinate, monitor and develop the sponsorship and foster care programme in the district.
