further to amend the Bodoland University Act, 2009..

preamble

Whereas it is expedient further to amend the Bodoland University Act, 2009, hereinafter referred to as the principal Act, in the manner hereinafter appearing;

Assam Act

It is hereby enacted in the Seventy-ninth Year of the Republic of India as follows :

Short title,  
extent and  
commencement

- i. (1) This Act may be called the Bodoland University (Amendment) Act, 2018.
- (2) It shall have the like extent as the principal Act.
- (3) It shall come into force at once.

Amendment  
of section 17

2. (1) In the principal Act, in section 17, after clause (xiii), the following new clause shall be inserted, namely :-

“(xiv) Principal Secretary, Bololand Territorial Council and Director of Education, Bodoland Territorial Council who shall be the representative of the Bodoland Territorial Council, Assam.”

**Statement of Object of Reason**

The Executive Council of Bodoland University adopted a resolution in the meeting of 29<sup>th</sup> July, 2015 vide resolution No.15(ii), that two representatives duly nominated by the Bodoland Territorial Council, Assam is to be included in the Executive Council of the Bodoland University.

Thus, the State Government in the Higher Education Department decided to amend the Bodoland University Act, 2009 to implement the resolution of the Council.
