

No. ASE.313/2013/156.- Whereas representations from individual and different Associations have been received that some deserving candidates have been deprived for not having Bengali, Assamese, Hindi, Bodo subject as the case may be, as MIL subject in HSLC examination.

Whereas the Axom Sahitya Sabha also conduct one year Diploma course in Assamese language and some candidates having such diploma in Assamese language have submitted representation for relaxation of requirement of Assamese Language either as MIL or as any elective subject in HSLC or equivalent examination.

Whereas the Government is satisfied that the circumstances exist which render it necessary for it to accept the Diploma Certificate in Assamese language issued by the Axom Sahitya Sabha instead of requirement of Assamese Language either as MIL or as any elective subject in HSLC or equivalent examination in respect of the candidates who have qualified TET during 2016.

Now, therefore, under provision of rule 30 the Assam Secondary Education (Provincialised) Service Rules, 2003, the Governor of Assam is hereby pleased to accept the Diploma Certificate in Assamese language issued by the Axom Sahitya Sabha in case of requirement of Assamese Language either as MIL or as any elective subject in HSLC or equivalent examination in respect of the candidates who have qualified TET during 2016.
