7.	In Hill areas	40

Besides, parking of vehicles on the carriage way of NHs is strictly prohibited. The speed limits mentioned above is under normal visibility conditions only. The vehicular speeds are to be reduced suitably by the drivers under poor visibility conditions due to Fog / Heavy rain etc. The speed limits mentioned above will be affective from the date of issue of this Notification and until further order.

Zone was directed to cause an inclusive and efficacious enquiry for fixing of responsibilities for occurrence of breach to Brahmaputra Dyke from Bessamora to Haldibari under Majuli Water Resources Division on 26/07/2016 vide letter No. WR(CON) 10/2016/43 dtd.18/10/2016 : and

Whereas the Inquiry Officer has submitted his inquiry report vide letter no. SES/MISC-9/M.E./2016/446 Dated 28/11/2016 and letter no. SES/MISC-9/M.E./2016/04 Dated 11/01/2017 where the charges leveled against Shri Hari Prasad Gogoi, Junior Engineer, Majuli W.R. Division have not been proved.

Considering all aspects of the matter and having regard to the findings of the Inquiry Officer, the Governor of Assam is pleased to exonerate the officer from the charges and reinstate as Junior Engineer, Majuli W.R. Division. The officer is advised to be careful so that no such incident occurs in future.

The period of suspension is treated as on duty for all purposes. It is also decided to pay proportionate pay under the provision of Sub-rule 8 of the F.R. 54 (B) which is restricted to the subsistence allowance already paid to Shri Hari Prasad Gogoi, Junior Engineer for the period of suspension.
