**SPEAKING ORDER**

**No. CON. 33/2015/188.** - Whereas the Finance (A&F) Department with the approval of the Hon'ble Chief Minister, Assam had forwarded C & AG's report on suspected misappropriation and loss of Govt. money to the tune of Rs.3.82 Crore in respect of PMGSY package No.AS-17-41 in Morigaon Rural Roads Division under the Superintending Engineer, PWRD, HPIU, Nagaon.

And whereas Sri Abdul Kader Superintending Engineer (the then Executive Engineer, Morigaon Rural Road Division) was suspended vide notification No.CON.33/2015/101 dated-18-06-2015 after obtaining detailed report from the Empowered Officer, ASRB dated-08-05-2015 and Show Cause notice was issued vide notification dated- 04-07-2015 to Sri Kader Superintending Engineer with the charges viz. (1) violation of PMGSY guidelines and negligence to Govt. entrusted duties and (2) lack of contract management resulting in loss of Govt. money.

And whereas Sri Abdul Kader Superintending Engineer has submitted replies to the Show Cause notice vide his letter dated-24-07-2015 and prayed for dismissal of the charges and to re-instate him in service. Subsequently, a hearing of Sri Abdul Kader was conducted by the Commissioner & Special Secretary on 09-09-2015 in his office chamber and decided to conduct an enquiry to find out the facts (Proceeding of hearing dated-16-09-2015).

And whereas an enquiry was conducted into the allegations by the then Chief Engineer, PWD (ARIASP & RIDF) Sri Ranjeet Kr. Das and whereas the Inquiry officer held Sri Abdul Kader guilty of the charge No.1 and the Enquiry Report reveals that Sri Kader having processed the bills pertaining to Mobilization and Equipment advances without verifying the Bank Guarantees submitted by the contractor, issued by the Udyogik Samabai Bank Ltd. which is not a Commercial Bank as per RBI report, has acted in a callous manner, for which the Department has suffered losses.

And Whereas Sri Kader approached the Hon'ble Gauhati High Court vide W P (C) No.2450/2016 and the court vide order dated-17-11-2016 passed in I.A (Civil) 1436/2016 in W P (C) No.2450/2016 has modified its earlier order dated-19-08-2016 and directed to duly communicate to the petitioner the order disposing his representation available with the respondents on or after 12-05-2016 and to finally close the departmental proceeding drawn up against the petitioner/Sri Kader within a period of 6 (six) weeks).

And whereas in the Meeting of the Public Accounts Committee, Assam Legislative Assembly held on 23<sup>rd</sup> September, 2016, the Chairman on Para 2.2.3 (above mentioned C&AG's report) has decided and directed to (1) re-instate the service of the Superintending Engineer (Sri Kader) immediately and recover the remaining amount during his service period and (2) to submit a report before the committee by March, 2017 regarding the other punishment taken against the Executive Engineer.

Now, after careful consideration of all the aspects and non-recovery of considerable amount of Govt. money from the contractor concerned, the Govt. in PWD decided to re-instate Sri Abdul Kader Superintending Engineer, PWRD revoking the suspension order issued vide No.CON.33/2015/101 dated-18-06-2015 in service with the following penalties.

1. The period of suspension is to be treated as on duty only for pensionary purpose and salary for the suspension period shall be limited to subsistence allowance received or to be received by him.
2. Whole of his DCRG is to be recovered and his pension is limited to 50% of his net pension.

**SUBJECT :-** Timely publication of Government Notifications and other important matters in the weekly Official Gazette.

I am directed to say that it has come to the notice of Government that important notification having bearing on statutes and matters of immediate public interest are sometimes published in the Official Gazette on date much later than prescribed. Government have decided, therefore, to introduce the following system with immediate effect, which must be strictly adhered to in sending notice to the Assam Government Press for publication in the official Gazette.

1. In the first instance, it has to be noted that the printing of the weekly Gazette must be completed by the end of every Tuesday so that it may be duly published on every Wednesday.

2. Every notification and every other matter which is required to be printed and published in a particular issue of the Official Gazette must, therefore, reach the Deputy Director, Assam Government Press on the Monday of the week preceding the week in which it is required to be published. If this is not done it is infructuous requesting the Deputy Director, Assam Government Press to publish such notification or other matter in the next issue of the Gazette, the expression usually inserted in all endorsements made to the Deputy Director.

3. Wherever it is necessary to print and publish a notification on a specified date (excluding such Notification or communicate as are to be published in Gazette extraordinary) clear instruction of that effect must be given to the Deputy Director, Assam Government Press, both on the body of such notification within the indication at the top in the red ink and is a separate covering.

4. To achieve the objective in papers 2 and 3, it is essential that proper discretion should be exercised by the concerned officers in the Department or office and all matters for publication in the Gazette should scrutinised and sent to the Press after careful application.

5. As for publication of any matters in a Gazette, Extraordinary, the existing procedure whereby the prior approval of the General Administration Department is to be obtained will continue.
