The 3rd April, 2017

No. SWD. 378/2014/56. - Smt. Bibha Gogoi, the then Child Development Project Officer (CDPO), Nazira ICDS Project, Sivasagar (now retired) was placed under suspension vide Notification No. SWD.4/2008/29, dated 16.02.2008 as per report received from the Director, Social Welfare, Assam vide No. DSW(G) 242/2007/27, dated. 26/12/2007.

Subsequently the Director, Social Welfare, Assam vide this Department's Suspension Notification cited above was asked to furnish draft charge sheet vide memo of the said Notification but the Director, Social Welfare Assam failed to furnish the same even after reported reminders.

Smt. Bibha Gogoi was re-instated in service vide No. SWD.4/2008/65, dated. 14.11.2008 and posted as CDPO, North West ICDS Project, Jorhat which was later modified vide Notification No. SWD.4/2008/70, dated 26/12/2008 by placing her as CDPO, Nazira ICDS Project, Sivasagar.

Smt. Bibha Gogoi (the then CDPO) now retired had taken over charge as CDPO, Nazira ICDS Project, Sivasagar on 30.12.2008.

Thus, appeared to be a gap period from 16.02.2008 to 30.12.2008 without regularization.

Smt. Bibha Gogoi (now retired) had another gap period w.e.f. 01.04.2013 to 30.09.2013 in connection with extension of joining time pending for regularization. Smt. Gogoi filed a case before the Hon'ble High court vide W.P.(C) No. 3262/2014 (Smt. Bibha Gogoi -Vs-State of Assam & Others) due to non-regularization of both the gap period.

The Hon'ble High Court Order dated 12.03.2015 directed Respondent No. 1 and 2 i.e. the Commissioner & Secretary, Social Welfare Department and the Director, Social Welfare, Assam to regularize the service of the petitioner, Smt. Bibha Gogoi for the period from 16.02.2008 to 30.12.2008 and 01.04.2013 to 30.09.2013 and to release full salary for the aforesaid period within 3 (three) months from the receipt of the certified copy of the order.

Accordingly, the Department vide a Speaking Order No. SWD.2152014/23, dated 02.07.2015 asked amt. Bibha Gogoi to submit prayer for extension of joining time, in compliance of Hon'ble High Court's Order dated. 12.02.2015.

In the meantime, Smt. Bibha Gogoi retired from service as District Social Welfare officer on attaining the age of Superannuation on 31.01.2015 (A.N).

Later on, the period of extension of joining time w.e.f. 01.04.2013 to 30.09.2013 was regularized vide this Department's Notification No. Social Welfare Department.378/2014/53, dated 09.03.2016 in the strength of Finance Department O.M. No. FEG,14/95/37, dated 20.08.2008.
