#### **NOTIFICATION**

The 6th March, 2017

**No. FRE-3/2017/31.**— In partial modification of the guideline for grant of Ex-gratia for loss of human life and injuries/damage to crops & property caused by wild animal, issued vide this Department Memo. No. FRS.-52/2007/35 dated 06/03/2010, Memo No. FRS.-52/2007/15-A dated 15/03/2008 and Letter No. FRE.-140/2014/9 dated 18/12/2014, the rate for payment of ex-gratia for loss of human life, loss of limb(s), damage to liovestock, crop damage etc. caused by wild animals is revised by enhancing the amount presently being paid as per details given below:

### ENHANCEMENT OF EX-GRATIA / COMPENSATION FOR LOSS OF HUMAN LIFE AND INJURIES / DAMAGE TO CROPS AND PROPERTIES CAUSED BY WILD ANIMALS

Sl. No.	Type of Damage	Revised Rate of Ex-Gratia Amount
1.	Ex-Gratia Payment to families of deceased persons	Rs. 4.00 lakh per deceased person.
2.	Ex-Gratia Payment for loss of a limb or eye(s).	Rs. 59,100.00 per person, when the disability is between 40% and 60%  Rs. 2.00 Lakh per person, when the disability is more than 60%  Subject to Certification by a Doctor from a Hospital or Dispensary of Government, regarding extent and cause of disability.
3.	Human Injury	Maximum Rs. 30,000.00 for medical treatment.
4.	Clothing and Utensils / Household goods for families whose houses have been damaged in Man Animal Conflict.	Rs. 1,800.00 per family, for loss of clothing.  Rs. 2000.00 Per family, for loss of utensils / household goods.
5.	Loss or Damage of Livestock.	Rs. 3,750.00 per cattle, for large cattle such as cow, buffalo etc.
6.	Crop Damage	Maximum of Rs. 7,500.00 per family.
7.	Damage to houses.	Maximum of Rs. 10,000.00 in case of mud / thatch houses depending on the extent of damage.  Maximum Rs. 95,000.00 per house in case of Pucca / RCC Houses depending on the extent

This has the approval of the Cabinet held on 28-02-2017.

These revised rates shall come into force with effect from 24-05-2016.
