The primary objective of the constitution of the society is to provide a local management body for the hospitals for its overall development and management. The main objectives of the society will be as follows:

- To improve service quality, system efficiency and patient satisfaction in hospitals.
- To ensure discipline and accountability amongst staff
- To generate revenue by proving services and charging from those who can afford
- To maintain and expand the existing hospital infrastructures including furniture.
- To encourage community participation in the management of health institutions.
- To arrange training for hospital staff.
- To maintain and expand the equipment and laboratory services.
- To supervise the implementation of health programme in the hospitals.
- To generate funds by public donation, leasing vacant lands for commercial users.
- To look into the public grievances regarding hospital and provide remedial measures.

#### **Functions of the Governing Body of the Society (abstract of the Scheme)**

The following major functions would be undertaken by the Governing Body Society to full fill its objectives.

- The Governing Body of the Society shall take general Policy decisions for improvement of the hospital services.
- The Governing Body shall prove general guidance and delegation of financial and administrative function to the Executive Committee of the society for execution of the policy decisions, maintenance and improvement of services in the Hospital.
- The Governing body of the society shall approve the Annual Budget of the Hospital in respect of revenue generated by the Hospital.
- Governing Body shall approve all proposals of the Executive Committee for a) new construction and for b) proving new modern diagnostic facilities in the hospital where financial involvement is more than Rs.5,00,000/-.
- The society shall exempt people from user fees as per State Govt. instruction issued in the matter from time to time.
- The Governing Body of the Society shall explore additional income generation activities by the hospital like leasing/renting space for cycle stand/scooter stand, canteen, medicine shop, PCO etc. and accordingly delegate the execution to the Executive Committee.

**Guidelines for selection of beneficiary**

1. Only Tea and Ex-Tea Garden Tribes should be selected against submission of TGL Case Certificates issued by competent authority or as may be satisfied to the authority.
2. Under one scheme only one beneficiary in a family should be selected so that maximum member of beneficiary families may be covered.
3. Same beneficiary should not be selected for subsequent period so as to stop repetition and misuse of benefits under schemes of Tea Tribes Welfare Department.
4. While selecting beneficiaries preference should be given to young entrepreneurs / unemployed youths / widows/ aged unmarried females / physically handicapped / BPL status besides general status beneficiaries.

**SUBJECT :-** Timely publication of Government Notifications and other important matters in the weekly Official Gazette.

I am directed to say that it has come to the notice of Government that important notification having bearing on statutes and matters of immediate public interest are sometimes published in the Official Gazette on date much later than prescribed. Government have decided, therefore, to introduce the following system with immediate effect, which must be strictly adhered to in sending notice to the Assam Government Press for publication in the official Gazette.

1. In the first instance, it has to be noted that the printing of the weekly Gazette must be completed by the end of every Tuesday so that it may be duly published on every Wednesday.

2. Every notification and every other matter which is required to be printed and published in a particular issue of the Official Gazette must, therefore, reach the Deputy Director, Assam Government Press on the Monday of the week preceding the week in which it is required to be published. If this is not done it is infructuous requesting the Deputy Director, Assam Government Press to publish such notification or other matter in the next issue of the Gazette, the expression usually inserted in all endorsements made to the Deputy Director.

3. Wherever it is necessary to print and publish a notification on a specified date (excluding such Notification or communicate as are to be published in Gazette extraordinary) clear instruction of that effect must be given to the Deputy Director, Assam Government Press, both on the body of such notification within the indication at the top in the red ink and is a separate covering.

4. To achieve the objective in papers 2 and 3, it is essential that proper discretion should be exercised by the concerned officers in the Department or office and all matters for publication in the Gazette should scrutinised and sent to the Press after careful application.

5. As for publication of any matters in a Gazette, Extraordinary, the existing procedure whereby the prior approval of the General Administration Department is to be obtained will continue.
