Whereas, vide Notification No.SWD.245/94/Pt.I/107-F, dated 30.07.1997 late Jhandilal Upadhyaya, the then CDPO, Lanka ICDS project was re-instated in the service pending drawal of DP and posted as CDPO, Ujani-Majuli ICDS Project, Jorhat District.

Whereas, late Jhandilal Upadhyaya, retired from his service on 29.02.2012 and expired on 20.04.2013.

Whereas, his suspension period have to be regularized w.e.f. 19.06.1994 to 15.09.1997 to release full salary for the aforesaid period.

Now, therefore, in view of the order of Sub-Divisional Judicial Magistrate, Hojai, dated 09.04.1997 U/S 406/409 IPC, Late Upadhyaya was found not guilty for offence and was acquitted and set at liberty, it is decided to conclude the Departmental Proceeding drawn against late Jhandilal Upadhyaya. As the Charges leveled against him could not be substantiated, his period of suspension with effect from 19.06.1994 to 15.09.1997 shall be regularized by treating the period as spent on duty for all purposes.
