The Government of Assam/Collector –cum- Appropriate Government is pleased to authorize the officers for the time being engaged in the undertaking with their staff and workmen to enter upon and survey and do all other acts required or permitted by section 12 of the Act.

No person shall make any transaction or cause any transaction of land specified in this preliminary notification or create any encumbrance on such land from the date of publication of this notification till such time as the proceedings of land acquisition is completed;

Provided that the District Collector may, on the application made by the owner of the land covered under this notification, exempt such owner from the above condition in special circumstances as per sub-section (4) of section 11 of the Act;

Provide further that any loss or injury suffered by any person due to his willful violation of the above provision under sub-section (4) of section 11 of the said Act shall not be made up by the Government.

Since the land is urgently required for the project, hence the state Government has decided not to carry out the Social Impact Assessment Study.
