If any advertisement without permission is detected then the penalty at the rate of 10 (ten) times the applicable tax will be realised from the advertising agency. If the advertising agency could not be identified then the liability will lie within the organiser of the event, owners of the establishment/product as the owner may be made to pay the penalty.

It is the duty of the advertising agencies to remove the advertising material immediately after expiry of the permission provided other than the permission holder will be liable to pay penalty at the rate of 05 (five) times the advertisement tax applicable.
