**No. PMA(S) 25/2017/19.** - As communicated by Govt. letter No. PMA(S) 184/2016/9 dated 03-11-2016 Government of Assam in Secondary Education Department issued instruction to exempt the fees payable to the Assam Higher Secondary Education Council for appearing in the Higher Secondary Examination and Board of Secondary Education, Assam for appearing in the High School Leaving Certificate Examination/ Assam High Madrassa Examination from the Government/ provincialized/ recognized venture School/ Colleges for the students whose annual income of their parents taken together from all sources is below or Rs 1.00 Lakh (Rupees one lakh) only.

After careful consideration Government of Assam in Secondary Education Department have decided to continue waiving of examination fees on an extended scale. This year, in addition to the Examination fees, centre fees charged by the Examination Centre for running the Examination will also be waived for the poor students appearing in HSLC and HSSLC examinations subject to observance of the following conditions:

1. For exempting the examination fees, center fees, school fees for examination etc of the student, the parents/guardian have to declare his income and the student will be eligible only if the income from all sources of the family is Rs 1.00 Lakh or below of it.
2. In support of the claim, the parent has to furnish some supporting evidence. The concerned head of the institution after examining the claim will allow the fees exemption of the student.
3. The fees amount thus not realized from the students directly by the AHSEC/SEBA due to the waiver of examination fees and centre fees, shall be reimbursed by the State Government after receipt of proposal from the AHSEC and SEBA through the Director of Secondary Education, Assam.
4. The AHSEC and SEBA, at the time of claiming reimbursement of examination fees should submit centre-wise and challan-wise detail list of exempted fees indicating nos of beneficiaries covered.
5. The reimbursement proposal must accompany the Utilization Certificate and progress report of previous grants.
6. The school can not collect any fees from the poor students for conduct of examination.
7. Duties and responsibilities of the students availing the scheme: It is mandatory for all the students of class X and the students seeking admission into HS 1<sup>st</sup> Year to have a tree plantation at their schools/colleges, at their homes or surrounding environment at the beginning of the academic session and place a photograph of his plantation work before the head of the institution. The student has to nurse the sapling and the same students at the time of appearing HSLC examination and after attaining Class-XI & XII as the case may be, have to place photograph of the self nurtured tree showing the progress of his plantation work before the head of the institution.

**Lett. No. PG. 22/70/P-II/1**, dated Shillong, the 2nd June, 1970 from the Chief Secretary to the Government of Assam to all Administrative Departments, all Head of Departments, All Deputy Commissioners and Subdivisional Officers.

**SUBJECT :-** Timely publication of Government Notifications and other important matters in the weekly Official Gazette.

I am directed to say that it has come to the notice of Government that important notification having bearing on statutes and matters of immediate public interest are sometimes published in the Official Gazette on date much later than prescribed. Government have decided, therefore, to introduce the following system with immediate effect, which must be strictly adhered to in sending notice to the Assam Government Press for publication in the official Gazette.

1. In the first instance, it has to be noted that the printing of the weekly Gazette must be completed by the end of every Tuesday so that it may be duly published on every Wednesday.

2. Every notification and every other matter which is required to be printed and published in a particular issue of the Official Gazette must, therefore, reach the Deputy Director, Assam Government Press on the Monday of the week preceding the week in which it is required to be published. If this is not done it is infructuous requesting the Deputy Director, Assam Government Press to publish such notification or other matter in the next issue of the Gazette, the expression usually inserted in all endorsements made to the Deputy Director.

3. Wherever it is necessary to print and publish a notification on a specified date (excluding such Notification or communicate as are to be published in Gazette extraordinary) clear instruction of that effect must be given to the Deputy Director, Assam Government Press, both on the body of such notification within the indication at the top in the red ink and is a separate covering.

4. To achieve the objective in papers 2 and 3, it is essential that proper discretion should be exercised by the concerned officers in the Department or office and all matters for publication in the Gazette should scrutinised and sent to the Press after careful application.
