Functions assigned to the Directorate of Information Technology, Electronics & Communication (DITEC) are as follows.

1. To conceptualise, frame and implement Policies, Rules, and Regulations, Project / Scheme Guidelines relation to Information Technology, Electronics and Internet for the State of Assam.
2. Enforcement and implementation of Cyber Laws, the Citizen Charter, ICT Policy, e-Procurement Guidelines, Network Security, Administration of the Information Technology Act (21 of 2000) and other IT related laws as enacted by the State and the Government of India.
3. To Co-ordinate, Implement and Monitor various Policies, Programmes, Projects, Schemes and Guidelines under IT Department and Government of India.
4. To promote interaction in IT related matters with National & International agencies and bodies.
5. To promote Innovation, Standardization, Testing and Quality in IT application and procedures.
6. To Promote Information Technology in Education and Digital Literacy in remote & rural areas of the State.
7. To take initiatives for capacity building and development of Hardware/ Software industry including knowledge based enterprises, promotion of IT & ITeS, IT exports and maintain competitiveness of the IT & EMC industry.
8. To frame guidelines for e-procurement, ownership, utilization, maintenance and up-gradation of core IT infrastructure and assets created by the State.
9. To assist other departments in the promotion of E-Governance, E-Infrastructure, E-health, E-Commerce, etc.
10. To make audit and analysis of programmes and schemes implemented by the IT Department.
11. To discharge responsibilities concerning establishment and secretarial matters and co-ordinate with line Departments for implementation of policy guidelines.
12. To prepare Annual Plan & Budget Proposals, sanctions, disbursements of grants, subsidies, loans, etc.
13. To cater to all matters relating to personnel under the control of the IT Department.
14. To take over the ownership and operation of the projects and schemes implemented by Nodal Agency after the plan period to look after all the IT related issues.

SUB: OVERTIME ALLOWANCE, SPECIAL DUTY ALLOWANCE ETC.

No. FM. 30/2010/7. - In pursuance of the Government Resolution on the report of the 7th Assam Pay and Productivity Pay Commission and the report of the committee vide Notification No.FPC.1/2017/Pt/1 dtd 17th March, 2017, the Governor of Assam is pleased to revise the Overtime Allowance etc payable to the State Government employees as follows:

1. Overtime Allowance is admissible to the protocol Officers, Drivers, Room Bearers and others in the PB-1 and PB-2 working in Assam Bhawan/Assam House in cities outside Assam, except Assam House, Shillong who are required to work beyond 200 hours in a month. The allowance should be paid @ Rs 20/- per hour for the extra hours of work done by each employee without any ceiling on the extra hours of work to be compensated for.
2. LMV Drivers attached with the Ministers shall be paid special duty allowance of Rs 500/- per month for the period of such duty.
3. The Drivers engaged on VIP duty in General Administration Department shall be paid Rs 200/-per month.
4. Transport Allowance paid to the employees of Assam Bhawan/ Assam House outside Assam is increased to Rs.2000/- p.m. and shall be paid only to those employees who are not given accommodation within the premises of Assam House/Bhawan. Employees of Assam House, Shillong are not entitled to this allowance. [also mentioned in O.M. No. FM 12/2010/117 dated 26th April 2017 on the subject of Revision Rates of Travelling Allowance]
5. This will come into force with effect from the date of issue of the OM.
