No. HMB. 110/2009(VOL)/258.- Whereas, Departmental Proceedings was drawn up against Shri Mrinmoy Kumar Dawka, Superintendent . District Jail, Karimganj (the then Jailor, Central Jail, Silchar) as **per the directions of Hon'ble Gauhati High Court in W.P.(C)No.1547/2009 Shri Bijoy Bhattacharjee-Vs- State of Assam & Ors. on the charges of negligence of duties, gross misconduct etc. and accordingly a Show Cause Notice vide No.HMB.110/2009/164 dated 06.08.2013 was issued fully enumerating the charges; and**

Whereas, Shri Mrinmoy Kumar Dawka, the then Jailor, Central Jail, Silchar vide his letter dated 23.08.2013 submitted his written statement denying the charges framed against him and by explaining the facts and circumstances of the matter; and

Whereas, after careful examination of the written statement in defence submitted by Shri Mrinmoy Kumar Dawka, the then Jailor, Central Jail, Silchar and not being satisfied with the said explanations, **it was decided to hold an enquiry** into the matter and accordingly the State Enquiry Officer, Assam was appointed as Inquiring authority by an order issued vide No.HMB.110/2009/181 dated 28.10.2014; and

Whereas, the State Enquiry Officer, Assam vide letter No.ABE.29/2014/47 dated 09.12.2016 submitted his **enquiry report of the Departmental Proceedings** against Shri Mrinmoy Kumar Dawka, the then Jailor, Central Jail, Silchar concluding that the charges framed against the Delinquent Officer have not been proved; and

Whereas, after careful examination of the enquiry report and materials on record and the submissions made by the charged officer the Govt. has decided to accept the enquiry report of the State Enquiry Officer, Assam and drop the Departmental Proceedings drawn up against Shri Mrinmoy Kumar Dawka, the then Jailor, Central Jail, Silchar.; and

Now, therefore, the Governor of Assam is pleased to accept the enquiry report submitted by the State Enquiry Officer, Assam and drop the Departmental Proceedings drawn up against Shri Mrinmoy Kumar Dawka, the then Jailor, Central Jail, Silchar.

However, the fact that some articles were found to have been smuggled into the Jail premises by the inmates suggests that there was some laxity by the Jail Authorities for which, Shri Mrinmoy Kumar Dawka is hereby cautioned to be more careful while discharging his duties in future .The Departmental Proceedings is disposed of accordingly.

Term of Office :

The Term of office of the Chairperson and members (other than ex-officio members) shall be 3 (three) years.

Power, function and responsibilities :

Without prejudice to the provision of the Biological diversity Act,2002 (Act 18 of 2003) the Assam Biodiversity Board shall exercise powers, perform function and discharge responsibilities as laid down and mandated under the " Assam Biodiversity Rules, 2010".

Powers and responsibilities of the Chairperson :

The Chairperson shall exercise such powers and discharge such responsibilities as laid down and mandatory under section-15 of the "Assam Biodiversity Rules,2010" .

Function of the Secretary :

The Secretary of the Assam Biodiversity Board shall perform such function as laid down and mandatory under section-11 of the "Assam Biodiversity Rules,2010".

Terms of Reference of the Assam Bio-diversity Board :

1. The Activities of the Assam Biodiversity Board shall be essential and strictly governed by the provisions of the Assam Biodiversity Rules, 2010.
2. The Assam Biodiversity Board shall consult the National Bio-diversity Authority (NBA) and the Biodiversity Management Committees , as and when required, while taking decision relating to use of biological resources of the state and traditional knowledge associated with such resources.
3. The Assam Biodiversity Board shall, in the discharge of its functions and responsibilities under the Assam Bio-diversity Rules, 2010 be bound by such direction on question of policy as the state Government may give of it writing from time to time under sub-sections (1) of section -49 of the Biological Diversity Act, 2010. Provided that the Assam Biodiversity shall as far as practicable be given an opportunity to express its views before any direction is given under the said provision.
4. The Principal Chief Conservator of Forests (Biodiversity) will function as the Secretary of the Assam Biodiversity Board.
5. The Assam Biodiversity Board would from time to time as required.
6. TA/DA of non-official members would be born out of funds provided by the State Government for the purpose/State Biodiversity Fund. TA/DA of officials members would be borne by their respective parent Departments.
