THE ASSAM REPEALING (NO. 2) BILL, 2017

**A
BILL**

to repeal certain enactments

Preamble	<p>Whereas it is expedient to repeal certain enactments as specified in the schedule ;</p> <p>It is hereby enacted by Assam Legislative Assembly in the Sixty-eighth Year of the Republic of India as follows :-</p>
Short title	<p>1. (1) This Act may be called the Assam Repealing (No.2) Act, 2017. (2) It extends to the whole of Assam. (3) It shall come into force at once.</p>
Repeal of certain enactments	<p>2. The enactments specified in the Schedule are hereby repealed to the extent mentioned in the fourth column thereof.</p>
General savings	<p>3. The repeal by this Act of any Act in which such enactment has been applied incorporated or referred to ;</p> <p>and this Act shall not affect the validity, invalidity, effect or consequences of anything already done or suffered, or any right, title, obligation or liability already acquired, accrued or incurred, or any remedy or proceeding in respect thereof, or any release or discharge of or from any debt, penalty, obligation, liability, claim or demand, or any indemnity already granted, or the proof of any past act or thing ;</p> <p>nor shall this Act affect any principle or rule of law, or established jurisdiction, form or course of pleading, practice or procedure, or existing usage, custom, privilege, restriction, exemption, office or appointment, notwithstanding that the same respectively may have been in any manner affirmed, recognised or derived by, in or from any enactment hereby repealed ;</p> <p>nor shall the repeal by this Act of any enactment revive or restore any jurisdiction, office, custom, liability, right, title, privilege, restriction, exemption, usage, practice, procedure or other matter or thing not now existing or in force.</p>

STATEMENT OF OBJECTS AND REASONS

The Parliament enacted the Appropriation Acts (Repeal) Act, 2016.

The salient feature of the Act is to repeal the obsolete and redundant laws which have lost their significance. Altogether 12 (twelve) numbers of Appropriation Acts pertaining to the state of Assam have been identified and repealed.

Therefore, Finance (Budget) Department proposes for adoption of the Appropriation Acts (Repeal) Act, 2016 repealing the 12 (twelve) numbers of Appropriation Acts as specified in schedule indicated in Section 2 of the proposed bill.
