**No. HMA-19011/50/2017/POLITICAL(A)-H&P/73(eCF No. 6524).**-A huge burden of cases under trial in different courts of Assam has resulted in financial and social hardship for the citizens concerned, delay in administration of justice and disproportionate diversion of state exchequer. With a view to evolve a mechanism to minimize the pendency of cases at lower courts and to provide the litigants with speedy delivery of justice for the welfare of the residents of Assam, the Governor of Assam is pleased to constitute a **District Level Committee** comprising of the following members :

**District Level Committee:**

**Note:** If there is more than one Addl. District Magistrate in District, the District Magistrate shall designate one Addl. Distt. Magistrate specifically as the member of the committee.

**Note:** If there is more than one Addl. Superintendent of Police in district, the Superintendent of Police shall designate one Addl. Superintendent of Police specifically as the member of the committee.

**Terms of Reference:**

The Terms of Reference of the District Level Committee so constituted above shall be as follows :

- 1) The Public Prosecutor shall present a list of pending cases which have been pending for more than two years before the meeting in different courts of the district along with necessary information. The committee will consider each case and will forward to the Government for withdrawal of such cases through the Public Prosecutor who would thereafter file application for withdrawal before the court.
- 2) Priority shall be given to cases in which the prosecution witness has turned hostile or for any other reasons, in the opinion of the Public Prosecutor, there is no hope of the success of the case in court.
- 3) While recommending the withdrawal of cases, the committee shall have the responsibility to ensure that the withdrawal of the case does not result in a case of malicious prosecution against the State Government.
- 4) In cases of general nature that can be withdrawn, where the accused falls in the category of habitual criminal, if the committee constituted at the district level makes a decision, then such cases shall be sent to the State Government for consideration of withdrawal from Court.
- 5) In the matter of recommendation, the committee shall specify the opinion and the grounds of either recommendation/ rejection.
- 6) If the number of cases is excessive then a cell may be formed to assist the members of the committee so that the work can be done promptly and easily.
- 7) The cases which fall under the following categories will be considered by the Committee:
  - a) All the cases under Section 34 of Police Act.
  - b) Case of Section 29 of Assam Shops and Commercial Establishment Act, 1971.
  - c) The cases under section 294, 323, 279, 336, 341, 342, 337, 447, 448 and 506 of IPC.
  - d) Under section 34 (A) of the Excise Act in cases where the quantity of items seized is less than 5 liters and cases falling under section 36 .
  - e) Under the Motor Vehicles Act.
  - f) Public Gambling Act - cases under Section 13.
  - g) Other such offences, having provision of imprisonment up to 6 months with fine which may extend up to Rs 5,000/-

- h) Petty cases under Section 206(3) Cr.P.C.
- i) The cases in which the accused has already undergone imprisonment equal to or more than the prescribed period.

Provided,

- (a) the accused will not be liable to be subjected to more/ increased punishment under Section 75 of IPC or any other provision for any subsequent offence.
- (b) any observation/ order/ judgment with regard to acquittal or conviction will not be awaited for, keeping in view the nature of crime and the criminal/ offender, for practical purpose.
- (c) Such criminal cases in which the accused and complainant have come to a compromise and only the charges of section 147, 148 and 149 of the Indian Penal code have remained.
- (d) All the criminal cases that are under consideration for more than the prescribed period of trial under Trial Magistrate, unless the case is of critical nature, which can be sent to the court of Chief Judicial Magistrate under section 325 of the Cr.P.C.
- 8) The Committee shall hold a meeting once in two months and send report of the progress of withdrawal of cases at the district level to the Govt. in Home & Political Department.
- 9) Detailed instructions regarding the functioning of the Committee shall be disseminated separately by the Judicial Department, Dispur.
