No. HMA. 727/2011/85.- Whereas a Departmental Proceeding was drawn up against Shri Promod Ch. Sarma, APS, the then Deputy Superintendent of Police (River Police) vide show cause No.HMA.727/2011/13 dated 14/02/2012 for gross misconduct and therefore, unfit to be retained in a disciplined force in connection with Basistha PS case No. 761/2011 U/s 365/34 IPC; and,

Whereas Shri Promod Ch. Sarma, APS submitted his written statement in defence and denied the charges leveled against him vide his letter dated 20/03/2012 and he prayed for exonerating him from the charges, and;

Whereas having not been satisfied with the written statement in defence submitted by Shri Promod Ch. Sarma, APS and after cateful consideration of all aspects, the Govt. decided to enquire into the allegations and therefore appointed Dr. L. R. Bishnoi, IPS as Inquiry Officer to enquire into the charges framed against Shri Promod Ch. Sarma, APS, vide Notification No. HMA 727/2011/27 dated 22/01/2013, and;

Whereas, the Inquiry Officer after causing an enquiry into the charges submitted his report to the Disciplinary Authority vide letter No. DR/VI/F-10(PS)/2013/784 dtd. 24/05/2013, wherein the Inquiry Officer concluded that the charges of gross misconduct and substantial evidence about direct involvement of Shri Promod Ch. Sarma, APS in kidnapping Akkash Ali in connection with Basistha PS case No. 761/2011 U/S 365/34 IPC against the delinquent officer could not be proved. However, the conduct shown by the officer in the whole episode was not as per laid down norms for serving Govt. officers,

Whereas, Shri Promod Ch. Sarma, APS the then Deputy Superintendent of Police (River Police) has already retired from service after attaining the age of superannuation during the course of the enquiry on 29/02/2012, and accordingly the Disciplinary Proceeding instituted against him has automatically got converted into a proceeding under rule 21 of the Assam Services (Pension) Rules, 1969.

Now therefore, after careful examination of the report of the Inquiry Officer and materials on records and also in consideration of the facts and circumstances, the report of enquiry officer is accepted and the Governor of Assam is pleased to order the infliction of minor penalty of "deduction of 20% pension for a period of one year (twelve calendar months)".

Under rule 21 of Assam Pension Rules, 1969, the Governor of Assam is therefore pleased to deduct 20% pension for a period of one year (twelve calendar months)" in respect of Shri Promod Ch. Sarma, APS, the then Deputy Superintendent of Police (River Police) now retired and the Departmental Proceedings drawn up against Shri Promod Ch. Sarma, APS, are thus finally disposed off.
