The Functions of the District level Executive Committee are as follows:

1. It will meet every month to review and monitor the progress of DAY-NULM implemented at the Urban Local Body/City Mission Management Unit level in a district;
2. Consider the Annual Budget and Annual Action Plan for all CMMUs in the District, its subsequent alterations placed before it to SMMU from time to time;
3. Accept donations and endowment and give grants upon such terms and conditions as it may think fit;

4. Appoint committees, sub-committees, expert panels, task force, working or study groups and boards etc. for such purpose and on such terms as it may deem fit and to remove any of them;
5. Appoint auditors for auditing the accounts of CMMUs in the District;
6. Ensure that the CMMUs in the District consider any comments made by funding agencies on the progress in the implementation of Mission/ projects sponsored and funded by them;
7. Monitor progress of CMMUs in the District to ensure achievement of Mission Objectives;
8. Monitor the financial position of the CMMUs in the District in order to ensure smooth fund flow and to review annual audited accounts.
9. It will play the role of Advisory Committee for EST&P component of DAY-NULM in Assam for the concerned district. This Committee in its regular meetings will keep specific agenda on Skills Training under DAY-NULM and will advise accordingly on various aspects like mobilization, counselling, trade selection, training quality, placement, etc. The District level Executive Committee may convene special meeting if there is need for discussion on any matter on urgent basis related to the EST&P component.
10. It shall undertake all such acts and things as may be necessary or incidental to carrying out the objectives of ASULMS or any of them provided that nothings herein contained shall authorize the District level Executive Committee to do any act or to pass any bye law which may be repugnant to the provisions hereof, to the powers hereby conferred on the District level Executive Committee and other authorities, or which may be inconsistent with the objectives of ASULMS.

The previous Govt. notification issued vide no. UDD(M)98/2013/Pt.XIII/43 dated 1st December 2015 is hereby declared null and void.
