NOTIFICATION

No. PMA(S) 25/2017/20.- The Board of Secondary Education, Assam(SEBA) has declared the results of HSLC Examination, 2017 on 31/5/17. On perusal, it is seen that only 47.94% of the students appeared have come out successful and 202179 students have failed in the Examination. After careful consideration of all aspects, the Govt. of Assam in Secondary Education Department has decided that SEBA will conduct a compartmental examination in order to facilitate the failed students. The SEBA will conduct the compartmental examination in such a way that the results can be declared within 20th August, 2017 and the students can take admission in class-XI in the current session itself.

For a meaningful compartmental examination all the stake holders have to extend their whole hearted support. The duties and responsibilities of the different stakeholders shall be as follows-

1. **Role of SEBA:-** They will conduct the examination as per their Rules and Regulations and will ensure that the result can be declared on or before 20th August, 2017.
2. **Role of Head of Institutions :-**
 - a. They will facilitate and motivate the students to appear in the compartmental examination. The online submission of form will start froms 5/6/2017 to 12/6/2017.
 - b. They will arrange special remedial coaching classes for these students. All the concerning teachers have to take coaching classes after the school hours during school days and during summer vacation in the day time. If possible coaching classes can be arranged in batches and in one batch there should not be more than 10 students for providing intensive coaching.

- c. In case of need, the Head of Institution can take the help of teachers of neighbouring schools and coaching may be done by making a cluster of schools.

3. Role of Inspector of Schools: –

- a. All the Inspector of Schools will have to make a detail plan for daily monitoring of the coaching classes held in each school through the DRISHTI program. A daily report has to be sent to RMSA, Assam on the coaching classes held in each school. All the Head of the Institutions shall be warned that if they fail to hold the coaching classes than stern disciplinary action will be taken against them. The same will also be applicable for the teachers who show apathy in taking the coaching class. The Govt. in Education Department will take a serious view if any negligency is reported against any stakeholders.
- b. He/She will arrange one examination centre in each District HQ and Subdivisional HQs for holding the compartmental examination. The examination will be held from 27th to 30th July, 2017 positively.

4. Role of RMSA, Assam:-

- a. The MD, RMSA will facilitate holding of coaching classes from their Learning Enhancement Program(Remedial teaching) and monitoring of the holding of coaching in each school under their DRISHTI program. Additional expenditure required for the same can be made from state plan fund, which is available with them. One ARP may be asked to monitor maximum 5 schools for proper monitoring of the programme.
- b. An online mechanism has to be developed for daily monitoring of the program.

5. Role of Director Secondary Education, Assam / Director of Education, BTC/ Addl. Director of Education(Hills), Haflong & IS, Karbi-Anglong:- They will monitor the activities of all the stake holders and coordinate the entire issue and see that the coaching of students is done in a very effective and systematic way. They will motivate the Academic councils, Teachers Associations and NGOs etc..to assist in the endeavour. The Autonomous Council authorities of Assam are also requested to monitor the activities of all stake holders.

6. Role of Principal Secretaries of Autonomous Councils:- They are requested to extend all necessary assistance to the schools, for smooth running of coaching classes.

7. Role of the Deputy Commissioners/SDOs(C): They will monitor the coaching in each school and they are authorized to take disciplinary action against the Inspectors of Schools, Head of the institutions and teachers, if any negligence in duty is found against them.
