- (b) The Civil Services Board shall examine the case of officers who are proposed to be transferred before completion of minimum period of services as specified under sub-rules (3) and (4) of rule 7 of the Indian Forest Service (Cadre), 1966.
- (c) The Civil Services Board may consider for transfer before the tenure fixed under sub-rule (3) and (4) of rule 7 of the Indian Forest Service (Cadre), 1966 based on such circumstances it thinks fit.
- (d) The Civil Services Board may recommend to the Competent Authority the names of officers for transfer before completion of minimum tenure with reasons to be recorded in writing.

**The procedures to be followed by the Civil Services Board are as follows:**

- (a) The Civil Services Board shall seek detailed justification from the Administrative Department of the State Government for the transfer of an Officer before the tenure.

**(b) The Civil Services Board shall-**

- (i) consider the report of the Administrative Department along with any other inputs it may have from other reliable sources;
  - (ii) obtain the comments or views of the Officers proposed to be transferred based on the circumstances presented to it in justification of the proposal.
  - (iii) not make recommendation for premature transfer of Cadre Officers unless it has satisfied itself of the reasons for such premature transfer.
- (c) The Civil Services Board shall submit a quarterly report in such Form as it thinks fit to the Central Government clearly stating the details of Officers recommended to be transferred before the minimum specified tenure and the reasons thereof.

Provided that the Competent Authority may reject the recommendation of the Civil Services Board for the reasons to be recorded in writing.

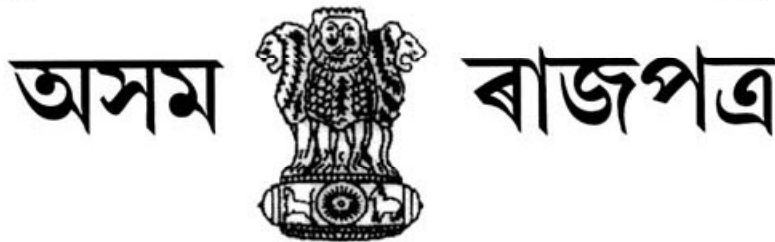
