- (1) To ascertain the circumstances leading to deaths of persons due to electrocution in the State since 1st April, 2017 with onset of monsoon season.
- (2) To identify persons/officials responsible for such deaths and lapses/errors on their part.
- (3) To ascertain the causes of technical faults/reasons causing these deaths.
- (4) To suggest to enhance safety measures including technical/managerial to avoid such deaths in future and minimise such fatal incidents.

Now, therefore, the Commission hereby invites written statements of facts/representations relating to the matter mentioned above from the Government of Assam, APDCL, aggrieved persons including the relatives/friends of the victims, parties, organizations and members of general public acquainted with the issues relating to the subject matter of the Inquiry.
