ASSAM STATE ELECTION COMMISSION

**NOTIFICATION**

The 22nd December, 2018

**No. SEC.31/2017/60.-** Whereas the Governor of Assam is pleased to entrust the Assam State Election Commission vide Notification No. HAD. 174/2012/90 dated 3<sup>rd</sup> December, 2012, to conduct the Election to North Cachar Hills Autonomous Council as per provision of Assam Autonomous Districts (Constitution of Districts Councils) Rules, 1951 ;

And, whereas subject to control and superintendence of the Assam State Election Commission, the respective Returning Officer viz; Deputy Commissioner Dima Hasao District prepared and published the Final Electoral Rolls of the respective Constituencies of the North Cachar Hills Autonomous Council, as per relevant provision of Assam Autonomous Districts (Constitution of District Councils) Rules, 1951 (as amended up-to-date);

And, whereas the Assam State Election Commission has duly taken notice of the Govt. Notification vide No. HAD 85/2018/13 dated 31<sup>st</sup> May, 2018, extending the term of the present Council by a period of six months with effect from 3<sup>rd</sup> June, 2018 or till the date of 1<sup>st</sup> sitting after completion of the fresh poll to the North Cachar Hills Autonomous Council to be conducted by the Assam State Election Commission, whichever is earlier ;

And, whereas the Assam State Election Commission has also duly taken notice of the Judgement & Order of the Hon'ble Gauhati High Court dated 08.11.2018 in Case No. PIL 36/2018 directing to complete the process for holding the Elections for the North Cachar Hills Autonomous Council and complete the process on or before 15.02.2019.

Now, therefore, in pursuance of the provision of Rule 124(2) and Rule 133(2) of Assam Autonomous Districts (Constitution of District Councils) Rules, 1951, the Assam State Election Commission calls upon the North Cachar Hills Autonomous Council Constituencies mentioned below at Part-A to elect Members to re-constitute North Cachar Hills Autonomous Council as per schedule given below at Part-B.
