- With due regard to the facts ascertained, to ascertain whether there was any lapse on the part of Police Administration in tackling the road blockade carried out by the local people at NH-15 leading to Police firing, resulting in the death of Moidul Islam, and if so, fix responsibility;
- 3. Any other matter which is relevant to the inquiry as may be decided by the Committee.

The enquiry report is to be submitted within 30 (thirty) days from the date of issue of this Notification.
