The Governor of Assam is pleased to constitute an One Man Enquiry Committee headed by Shri V B Pyarelal, IAS, Additional Chief Secretary to the Government of Assam, Finance etc Deptts to enquire into the circumstances leading to the violence that erupted at Maibang Railway Station on 25th January, 2018 during the 12 hour Dima Hasao District bandh called by various students and women organizations of Dima Hasao District in protest against the alleged inclusion of areas of Dima Hasao District in the proposed Greater Nagalim under the Naga Framework, the violence causing injury to personnel of police and civil administration and damage to public and railway property and subsequent use of force by Police personnel resulting in injury to several persons out of which 2(two) persons subsequently succumbed to their injuries.

The terms of reference of the Enquiry Committee are as follows:

- To ascertain the facts and circumstances leading to the violence that erupted at Maibang Railway Station on 25th January, 2018 causing injury to personnel of police and civil administration and damage to public and railway property, and subsequent use of force by Police personnel resulting in injury to several persons, out of which 2(two) persons subsequently succumbed to their injuries.
- 2. With due regard to the facts ascertained, to ascertain whether there was any lapse on the part of Civil Administration/Police in resolving the situation peacefully, and if so, fix responsibility;
- 3. Any other matter which is relevant to the inquiry as may be decided by the Committee.
- 4. Recommendations to ensure that there is no recurrence of such incidents.

The enquiry report is to be submitted within 30 (thirty) days from the date of issue of this Notification.
