#### **NOTIFICATION**

No.S(E)155/2015/107.- In exercise of the powers conferred by the proviso to the Article 309 of the Constitution of India, the Governor of Assam is hereby pleased to make the following rules further to amend the Assam Secretariat Subordinate Service Rules, 1963, hereinafter referred to as the principal Rules, namely:-

### Short title and commencement.

- 1. (1) These rules may be called the Assam Secretariat Subordinate Service (Second Amendment) Rules, 2017.
  - (2) They shall come into force on the date of their publication in the Official Gazette.

## Amendment of rule 10 (1).

- 2. In the principal Rules, in rule 10 for the existing sub-rule (1), the following shall be substituted, namely:-
  - "(1) By direct recruitment on the result of competitive examination conducted by the Selection Committee as per Schedule-II-A. 20(twenty) percent of the cadre strength approved for Computer Operators (English) shall be filled-up by Assamese Computer Operators."

Amendment of rule 18 (iii).

 In the principal Rules, in rule 18, in sub-rule (iii), for the existing provision the following shall be substituted, namely:-

"(iii) Educational Qualification: If he is a candidate for the post of Computer Operator he shall be a graduate in Arts, science or commerce from a University recognized by the State Government or a degree equivalent thereto and recognized by the Government."

## Insertion of SCHEDULE-II-A.

After "SCHEDULE-II, NOTE-(ii) Under Rule 8" a new schedule shall be inserted as follows, -

#### "SCHEDULE-II-A

#### NOTE (ii) under Rule 10

- 1. The competitive examination for direct recruitment of Computer Operator shall consist of an objective type test with multiple choice question and a Computer Proficiency Practical test for 100 marks in each test.
- The applicant shall have to clearly state in the application the post of Computer Operator they are applying for – Assamese Language Computer Operators, or English Language Computer Operator.
- 3. The syllabus of objective type written test shall be as follows:-

Total- 100

- 4. Against each vacancy four candidates shall be selected on the basis of the marks obtained in the written test. The candidates who have passed the written test shall have to appear in the Computer Proficiency test.
- Final selection shall be made on the basis of the total marks obtained in the written test and Computer Proficiency test."
