Das & Others for exclusion of Kanjuli Beel from No. 25/28/103/104 Dhipujjijan/Garanga /Garsag/Malia Group Fishery in Morigaon district dated 2nd November, 2016 recommended by the Hon'ble Local MLA, Jagiroad.

Perused: The reports submitted by DC, Morigaon vide letter No. MRF 1/2016/13 dated 21st March, 2017 with enclosures, No. MRF 1/2016/34 dated 8th January, 2019 with enclosures No. MRF 1/2016/54 dated 31st August, 2020 & vide No. MRF 1/2016/56 dated 3rd December, 2020.

Perused: The order of the Hon'ble Division Bench of the High Court dated 5th January, 2021 in Writ Appeal No. 142/2020 along with IA© No. 1679/2020 & IA© No. 2259/2020.

Perused: The order of the Hon'ble High Court dated 26th September, 2022 in WP© No. 628/2022 (Pakridobha MSS Ltd. Vs State of Assam & Others).

Perused: The Opinion of Legal Remembrancer, Assam vide U.O dated 4th May, 2021 & dated 1st October, 2022 in File No. FISH 31/2021( eCF No 210681).

Perused: Govt. earlier order vide No. FISH 330/2016/53(eCF No. 162922) dated 15th July, 2021.

Perused: Govt. order vide No. FISH 44/2021/307 dated 8th March, 2021 for settlement of the Fishery.

This is regarding public demand for exclusion of Kanjuli Beel from 25/28/103/104 Dhipujjijan /Garanga / Garsag /Malia Group Fishery in Morigaon since past 4/5 years. The contention of the public is that Kanjuli Beel along with 5 (Five) Other such areas namely Parjari, Angerkati, Baghpori, Rotha and Chapora have been included as connecting channel in No. 25/28/103/104 Dhipujjijan /Garanga / Garsag / Malia Group Fishery in Morigaon district. These Beels/areas were earlier used for cultivation, Grazing Ground for cattle as well as fishing by local public. Thus public of the locality are greatly inconvenienced for inclusion of Kanjuli Beel in the Govt. Fishery.

In this connection, local public submitted a representation which was sent to DC , Morigaon for inquiry and report. Accordingly, DC got the matter inquired through the Circle Officer, Mayong and forwarded the inquiry report to Govt. vide letter No. MRF 1/2016/13 dated 21st March, 2017.

From the report, it appears that Kanjuli Beel has been included in the above Group Fishery which has total land area of 130 Bigha 1 Katha which mostly remain under water. But the water level in March /April of a year is around 3/4 feet deep in around 30 Bigha of the area. Kanjuli Beel is connected with Garanga Beel in southern side. There is an area of Patta land under Dag No. 14 with 4B -3K -5L area. But other areas are all Govt. Khas land. As per report, approximate loss of Govt. Revenue will be around Rs. 1.00 Lakh annually, if the said Beel is excluded from the Govt. Notified Fishery. Similar report was again submitted by ADC Morigaon vide letter no. MRF 1/2016/34 dated 8th January, 2019 along with field inquiry report of Circle Office, Mayong.

Further, CO Mayong also took public hearing of all concerned and forwarded the proceeding of outcome of the public hearing taken in this regard through the ADC , Morigaon vide letter No. MRF 1/2017/54 dated 31st August, 2020.

Finally, DC, Morigaon offered views/opinion on the above proposal and recommended the exclusion of Kanjuli Beel from the 60% Govt. Registered Fishery vide No. 25/28/103/104 Dhipujjijan /Garanga / Garsag /Malia Group Fishery in the greater interest of public of the area vide letter No. MRF 1/2016/56 dated 26th November, 2020. The DC was of the opinion that exclusion of Kanjuli Beel from the Govt. fishery is in the interest of local public and the loss of revenue as assessed by LR staff will be compensated by welfare/Development works that can be carried out in the area for cultivation and such other schemes.

In this connection, Govt. took views of L.R Assam as the 25/28/103/104 Dhipujjijan /Garanga/ Garsag /Malia Group Fishery of which Kanjuli Beel is a part has already been settled through Tender system in the light of order/direction of the Hon'ble Division Bench dated 5th January, 2021 in Writ Appeal No. 142/2020 linked with IA© No. 1679/2020 & IA© No. 2259/2020 vide Govt. order dated 8th March, 2022.

The Legal Remembrancer, Assam in his detailed opinion vide U.O. dated 4th May, 2021 agreed to the proposal for exclusion of the Kanjuli Beel from the notified Govt. Fishery in the light of provision Rule 2 & 48 of Assam Fishery Rules, 1953 . However, LR opined that if the fishery has already been settled in terms of order of the Hon'ble Division Bench quoted above, Govt. may look into the legal aspect of the matter to avoid any legal complicity.

In the meantime, the instant Writ Petition vide WP© No. 628/2022 was filed by the lessee of the Fishery and Govt. was of the view that it will be prudent to decide the matter of exclusion of Kanjulee Beel based on outcome of the writ petition and hence further action was kept in abeyance in terms of Govt. order dated 15th July, 2021 Now the said Writ petition has been disposed of on withdrawal by the Hon'ble High Court vide order dated 26th September, 2022 and as such there is no legal impediment to go ahead with the proposal based on proposal/report of DC, Morigaon vide letters under reference as opined by LR, Assam vide U.O dated 1st October, 2022.

Govt. after careful consideration of all materials in hand including report and recommendation of DC Morigaon in the light of memorandum of local public of greater Mayong area, order of Hon'ble Division Bench dated 5th January, 2021 in Writ Appeal No. 142/2020 and Linked cases, Govt. order Dated 8th March, 2021, order of the Hon'ble High Court dated 26th September, 2022 in WP© No. 628/2022, opinion of LR, Assam vide U.O dated 4th May, 2021 & U.O dated 1st October, 2022 and in exercise of powers conferred U/R 2 R/W Rule 48 of Assam Fishery Rules, 1953, is pleased to allow exclusion of Kanjuli Beel from 25/28/103/104 Dhipujjijan/Garanga / Garsag /Malia Group Fishery in Morigaon district on following terms and conditions:

- 1) The total area of 130 Bigha -1 Katha -0 L of Kanjulee Pathar Kisamat under Dag No. 1 out of 1395B-0K- 9L excluding Patta land of 4B-3K-5L under No. 1 Myadi Patta & Dag No. 14 of the same Kisamat with effect from date of identification/demarcation and handing over by the C.O Mayong to the authorized representatives of local public in presence of representative of lessee of the fishery.
- 2) The boundary of No. 25/28/103/104 Dhipujjijan/Garanga/Garsag/Malia Group Fishery to be redefined after exclusion of Kanjulee Beel and Draft Notification with redefined boundary submitted to Govt. in Revenue & DM Department through Fishery Department for publication by Revenue & DM Department.

- 3) The revenue of the fishery with redefined boundary shall have to be re-assessed through District Fishery Development Officer, Morigaon U/R 48 of Assam Fishery Rules, 1953 based on existing lease value of the fishery @ Rs. 28,55,000.00 PA in terms of Govt. order dated 8th March, 2021.
- 4) The lessee shall have to pay revenue as per existing lease value up to date of handing over Kanjulee Beel and after that as per re-assessed revenue approved by DC, Morigaon.
- 5) Consequent upon exclusion of the area with publication of Notification by Revenue & DM Department under administrative control of DC Morigaon by the local public under the banner of Mayong Anchalik Unnayan Samity after verifying the credential of the public body whether it has been properly constituted and registered under competent Authority.

**Let. No. PG. 22/70/P-II/1**, dated Shillong, the 2nd June, 1970 from the Chief Secretary to the Government of Assam to all Administrative Departments, all Head of Departments, All Deputy Commissioners and Sub-Divisional Officers.

**SUBJECT :-** Timely publication of Government Notifications and other important matters in the weekly Official Gazette.

I am directed to say that it has come to the notice of Government that important notification having bearing on statutes and matters of immediate public interest are sometimes published in the Official Gazette on date much later than prescribed. Government have decided, therefore, to introduce the following system with immediate effect, which must be strictly adhered to in sending notice to the Assam Government Press for publication in the Official Gazette.

1. In the first instance, it has to be noted that the printing of the weekly Gazette must be completed by the end of every Tuesday so that it may be duly published on every Wednesday.

2. Every notification and every other matter which is required to be printed and published in a particular issue of the Official Gazette must, therefore, reach the Director, Assam Government Press on the Monday of the week preceding the week in which it is required to be published. If this is not done it is infructuous requesting the Director, Assam Government Press to publish such notification or other matter in the next issue of the Gazette, the expression usually inserted in all endorsements made to the Director.

3. Wherever it is necessary to print and publish a notification on a specified date (excluding such Notification or communicate as are to be published in Gazette extraordinary) clear instruction of that effect must be given to the Director, Assam Government Press, both on the body of such notification within the indication at the top in the red ink and is a separate covering.
