No. NCHAC/GAD/TC/HARANGAJAO/2019-20.-In pursuance of the decision of the Executive Committee meeting held on 13th January' 2016 under Resolution No.16 regarding declaration of urban area of Harangajao for proposed Harangajao Town Committee and on receipt of report from the Secretary i/c Rev. (W) vide letter No. Rev/APP/4/Misc/TC/2019-20/Dtd.27-11-2019 and another report from the Assistant Director, Town & Country Planning vide letter No.DPU/TCP/AC/28/2019-20/391/Dtd.26-11-2019 and in view of the growing importance of Harangajao Bazaar and consequent increase in population and improvement of the area, the Executive Committee of N.C. Hills Autonomous Council, Haflong, is of the opinion that improved arrangements have become necessary to deal with all or any of the matter referred to in the schedule appended to the North Cachar Hills District(Administration of Town Committees) Act' 1956. Notice is therefore hereby given under Sub-Section 3(1) of the said Act to signify the intention of the Executive Committee of N.C. Hills Autonomous Council, Haflong, to constitute a Town Committee of Harangajao within the area specified and appended herewith.
