No. HMA-19032(11)/51/2017/Pol(A)-H&P/138 (ECF-28983).- The following SOP/Guideline is framed to ensure that buffalo and other traditional birds fight are allowed to be organiszed in all places where it has been traditionally organized with specific provisions for regulation by the district administrations to ensure that cruelty to animals is not allowed to be inflicted.

Background of Buffalo Fight:

The event of Buffalo fight (Moh-juj) is an integral part of the culture and tradition of Morigaon and Nagaon districts etc. in Assam for centuries. The event was organized formally during Ahom's Rule specially in Rang Ghar. It is observed mainly during Magh Bihu festival. The politico-economic relationship between Tiwa Chief (Gobha Raja) of then undivided Nagaon district and Ahom Barphukan and the tradition of the Jonbeel festival bridged the gap between the two historical kingdoms of Assam which smoothened the road through which the tradition of Moh-juj could flow to undivided Nagaon District (Nagaon & Morigaon district) from Rang Ghar. Historians believe that Moh-juj was practiced in undivided Nagaon district in the different form (unorganized and unprofessional) before the 17th century. The relationship resulted in the intermixing of cultures and traditions between the people of Tiwa and Ahom Kingdoms, which culminated in the formal introduction of Moh-juj in the undivided Nagaon District.

The Hon'ble Gauhati High Court vide Order dated 10th October, 2023 passed in WP(C) No. 73/2016 directed the State Govt. of Assam through the Chief Secretary to look into the aspect of the long standing tradition of buffalo fights being performed in the State of Assam during the festival of Magh Bihu which is a part of the tradition as well as the aspect of the well-being of the animals being put to jeopardy because of any provocative acts being inflicted by the organizers and thereupon to take a conscious decision on the matter.

The Hon'ble Cabinet on 8th December, 2023 decided that buffalo and other traditional birds fight can be allowed to be organized in all places where it has been done traditionally over the years and directed Home and Political Departments to come up with a comprehensive SOP to ensure that buffalo fights are allowed to be organized in all places where it has been done traditionally with specific provisions for regulation by the district administrations to ensure that cruelty to animals are not allowed to be inflicted. Accordingly, the following SOP is prescribed for buffalo fight and Bulbuli birds fight.

Background of Bulbuli Birds Fight:

Although there is no documented history about when Bulbul fights started, old-timers say it was started by the great Ahom King Swargadeo Pramatta Singha during his rule between 1744 and 1751. People believe that the king saw two Bulbul birds fighting while descending the stairs of the temple. Thousands of people from across Assam converge on the town of Hajo in lower Assam's Kamrup district to witness the famous Bulbul fight that takes place during Bhogali Bihu celebrations every year.

In view of the Order dated 7th May, 2014 passed by the Hon'ble Supreme Court in SLP (Civil) No. 11686/2007 (Animal Welfare Board of India vs-A. Nagaraja & Ors.) the Government of Assam issued an order dated 13th January, 2015 prohibiting bulbuli fights during the festival of Bihu. Sri Sri Hayagriba Madhav Temple Committee of Hajo challenged the ban imposed in the Hon'ble Gauhati High Court through WP (C) No. 5228/2015. The Hon'ble High Court vide Order dated 22nd December, 2023 opined that the Supreme Court's decision rendered in the context of injuries inflicted on the racing bulls, cannot be justified for banning the ritualistic bird fights, in the Sri Sri Hayagriba Madhav Mandir premises and kept the ban order dated 13th January, 2015 in abeyance, until further orders.

Standard Operating Procedure (SOP)/Guideline for Moh-juj (Buffalo Fight):

- 1. District Administration should ensure that all rules and regulations along with the SOP is strictly followed. Concerned District Commissioner will issue permission to the organizing committee on the basis of the application from the organizers.
- 2. Moh-Juj shall be allowed only in those places where there is a history of organising such events (at least 25 years).
- 3. Moh-Juj may be allowed at a specific time of a year to be completed within ten days succeeding Magh Bihu (i.e. from 15th to 25th January). No Moh-Juj shall be allowed any time of the year except the period stated.
- 4. The organizing committee shall ensure that Moh-Juj is scheduled between 7.00 AM and 4.00 PM.
- 5. Veterinary department will depute a veterinary team at the spot where Moh-Juj is organized to respond to any medical emergency to buffaloes. Where Moh-Juj is organized in large scale. Veterinary ambulance will be made available at the spot along with veterinary team.
- 6. Organizers of Moh-Juj must make arrangements of sufficient food, water and sun-shade for buffaloes at the venue, as may be necessary.
- 7. The complete Moh-Juj program showing date, time and place shall be videographed. The organizing committee should ensure the proper videography of the complete event.
- 8. Strong barricading of the fighting arena shall be done by the organizing committee.
- 9. All human inflicted injuries shall be prohibited at any cost.
- 10. Only healthy male buffalo shall be engaged for the fight.
- 11. The organizing committee shall ensure that no sharp objects or any instruments causing physical injury to instigate the buffaloes are allowed in the fighting ground.
- 12. No intoxicating items (like opium) or performance enhancing drugs will be fed to the buffaloes.
- 13. A written undertaking for complying with the rules incorporated in the SOP should be made compulsory from organizing committee for obtaining permission from District Administration.

Standard Operating Procedure (SOP) for Bulbuli birds fight:

- 1. Bulbuli birds should be kept completely safe.
- 2. Food items and water to be fed to the Bulbuli birds at the venue. Safety and security shall be closely monitored by the organizing committee.
- 3. The game of Bulbuli birds fight must be conducted in a well-disciplined manner.

- 4. In the game of Bulbuli birds fight, the management committee shall set up barricades and conduct the games in the completely safe manner.
- 5. No persons other than 2 marchers and 2 judges will be allowed to enter the stage.
- 6. Owner of the Birds must sit in specially reserved seats in disciplined manner.
- 7. The game management committee will make proper seating arrangement for the audience to enjoy the game.
- 8. The organizers shall ensure after the game is over the Bulbuli birds must be released in the open air in perfect condition.

If any organizing committee is found violating the stipulations as mandated above, the event shall be banned for next five years. These shall be applicable to both buffalo fight and bulbuli fight. Both buffalo and Bulbuli fights shall be permitted only at the places where both the fight have been traditionally conducted for the last 25 years.
