The following guidelines are issued:-

- 1) The Committee will have meeting once in a month.
- 2) The Chairman of the Committee will be entitled for a remuneration of Rs. 5000/- (Rupees Five thousand) per month. Other non-official members will be entitled for Rs. 250/- (Rupees Two Hundred and Fifty) per sitting.
- 3) The Quorum of the meeting will be 9 (Nine) Members.

Functions and Duties

The functions and duties of the Thana Level Nagrik Committees will be as follows:

- a. To facilitate timely delivery of the citizen centric services of the police department like passport verification, character verification, injury reports, vehicle insurance claim report, reports on various relief services during disaster etc.
- b. To ensure faster response of Police against grievances registered in Police Station or forwarded by the state or district.
- c. To look into incidents of alleged misbehavior, if any.
- d. To provide information and community feedback for improving policing in the area.
- e. Use various public forum including media for pushing forward the concerns for Police actions in matters of National Security and Public good as well as other issues pertaining to social interests.
- f. To create public awareness on important social legal issues like human trafficking Drug abuse, witch hunting, domestic violence, violence against women and children, care and maintenance of parents/senior citizens, alcoholism, tobacco control, juvenile justice, unscrupulous financial companies and other such institutions.

The Committee will come into force with immediate effect. After the formation of the committee, there will be monthly meetings. The copy of the Minutes of the meeting shall be forwarded to CM office, Home Department, DGP Office and SP office. The same will have to be uploaded in the portal in the event of development of such portal.

5. DEARNESS ALLOWANCE:

Dearness Allowance applicable to the State Government employees will be applicable to the judicial officers as well.

6. EXERCISE OF OPTION.
