Department, Silchar has submitted his Inquiry Report vide letter No. CEWR(C&H)E/317/2020/7 dtd. 10/12/2020 and clarification regarding the Inquiry Report vide letter No. CEWR(C&H)E/317/2020/9 dtd. 03/06/2021 against W.R. Department's letter No. WR(CON) 1/2020/65 dtd. 15/03/2021.
