No. AAI.30/2022/8.- Whereas, Hon'ble Cabinet in its meeting dated 7th October, 2022 has approved as Additional Item No.2 for Incentives/Special Allowance to be granted to All India Service officers of Assam Segment of Assam-Meghalaya Joint Cadre presently serving in Assam as a relief.

And Whereas, the approval has been granted w.e.f. 23rd September, 2022.

And Whereas, Hon'ble Cabinet has stated that these Incentives/Special Allowance @20 (twenty) percent of basic salary may be given only to those All India Service Officers who are already in the service on the date of approval i.e. 7th October, 2022.

And Whereas, Finance Department vide its endorsement dated 2nd November, 2022 in File No.AAI.32/2022 (eCF: 240597) has reiterated that these allowances may be given only to those All India Service Officers who are already in service.

Therefore, the Governor of Assam is pleased to allow Special Allowances @20 (twenty) percent of basic salary to be reimbursed to the AIS officers serving in the state of Assam from the Consolidated Fund of the state w.e.f. 23rd September, 2022. The reimbursement shall be remitted to the officers who were allowed Special Allowances by Government of India prior to the withdrawal and will not be applicable to the officers who are yet to serve the Assam Segment of the Assam-Meghalaya joint cadre.
