<u>Term of Office</u>: The Chairman, Vice-Chairman and Members of the Sub Divisional SC Development Board shall hold their position in the board at the pleasure of the State Govt. The State Govt. may, at any time, change the Chairman/Vice Chairman/Member of the Development Board or may dissolve the Development Board or may reconstitute the Development Board.

The Development Board shall stand dissolved on completion of three years from the date of notification, unless dissolved earlier.

No.FEG.14/2021/18.- Consequent upon the decision taken by the Government of Assam relating to Annual Privileged Leave in respect of Forest Department personnel from the level of Constable to Sub-Inspector under the Assam Forest Protection Force (AFPF) working in the National Parks & Wildlife Sanctuaries etc., the Governor of Assam is pleased to order that in the Fundamental Rules and Subsidiary Rules in Appendix-33 the following shall be added as the Appendix-33(A)

#### APPENDIX-33(A)

The personnel of Assam Forest Department from the level of Constable to Sub-Inspector under the Assam Forest Protection Force (AFPF) working in the National Parks and Wildlife Sanctuaries etc., may be granted Annual Privileged Leave (APL), a kind of compulsory leave by an authority competent to grant leave for a maximum period of 30 days in a calendar year.

- 1. The leave may be called "Annual Privileged Leave" and be abbreviated as "APL".
- 2. This shall come into effect from the 1st of January, 2022.
- The leave is applicable to the personnel of Assam Forest Department from the rank of Constable to Sub-Inspector under the Assam Forest Protection Force (AFPF) working in the National Parks & Wildlife Sanctuaries etc.
- 4. Subject to the provision in rule '2' the entitlement of the leave is as follows:-

Constable to Sub-Inspector under the Assam Forest Protection Force working in the National Parks & Wildlife Sanctuaries :	:	,
The AFPF personnel posted for protection and security of forests,		30 days
forest produce and wildlife in Territorial and Wildlife Divisions are often		
cutoff from their families for month together and they live under difficult		
conditions and not permitted to stay with family in the off duty time.		

- The concerned Commandant of the Assam Forest Protection Force Battalions shall be the competent authority to grant the leave.
- Leave salary equal to full normal pay of the preceding month of availing this leave shall be admissible.
- 7. The leave is lapsable at the end of the calendar year and cannot be carried forward except under exceptional circumstances in public interest as decided by higher authority with a special order detailing the reasons. The carrying forward of this leave can be allowed by such an order by the PCCF & HoFF, Assam as well as the PCCF (Wildlife) to avail the leave in the subsequent year.

- Under no circumstances, the leave can be encashed.
- 9. The leave cannot normally be coupled or joined with any existing leave.
- 10. The leave shall be availed enbloc and cannot be fractioned.
- 11. No extension of leave is permissible. Personnel who have not joined on the due date from leave shall be dealt as per the rules provided for "Unauthorized Absence".
- 12. Leave Roster/ Calendar for the APL shall be prepared by concerned DFOs and Commandants well in advance by obtaining choice from the personnel to accommodate their choice in the best possible manner. The year will be divided into four quarters and the period of leave shall coincide with the calendar month of the year. A person availing the leave for a particular quarter (say Q1) will have to select the month from next three quarters during the next three consecutive years before he can avail leave in the same quarter (say Q1) again. It shall be ensured that not more than 9% of eligible staff avail this leave at any point of time for any month.
- 13. A person will be entitled to full quota of APL in a particular year if he has worked throughout in the previous year at the corresponding level. If the period of duty rendered is less, the period of APL will be changed proportionally.
- 14. The general conditions governing the other types of leave would be applicable which, inter alia, include that the leave cannot be claimed as a matter of right and public interest would always have primacy over leave entitlement.
- 15. The "Annual Privileged Leave" cannot be denied unless in case of exigency of grave public interest of high security requirements, and such denial has to be approved by an officer at the level higher than the leave sanctioning authority by means of a Speaking Order with intimation to the PCCF & HoFF, Assam as well as the PCCF (Wildlife).

Whereas the Government of Assam in the Department of Finance (Estt.-A), vide Notification No. FEG.28/2017/26 Dated 14-09-2017 has introduced the Scheme of Compassionate Family Pension in lieu of the Compassionate Appointment Scheme with a view to providing immediate financial relief to the families of the State Government employees who die in harness on or after 01-04-2017 and;

Whereas pursuant to the introduction of the Compassionate Family Scheme, the Government of Assam in the Department of Pension and Public Grievances, vide Office Memorandum No.PPG(P)292/2017/1 dated 31-10-2017 has issued revised guidelines for payment of family pension to the State Government employees who die in harness on or after 01-04-2017 and;

Whereas as per para 5.9 of the Finance (Estt.-A) Department's notification No. FEG.28/2017/26 Dated 14-09-2017 CFP Scheme is also applicable to the All India Services Officers borne on Assam Cadre besides the State Government employees of Assam and:

Whereas it has been observed that guidelines extending the benefit of Compassionate Family Pension to the families of the All India Services Officers borne on Assam Cadre who die while in service on or after 01-04-2017 has still not been issued;

Now, therefore, the Government of Assam, after due consideration, has decided to extend the benefit of Compassionate Family Pension to the Families of the All India Services borne on Assam Cadre who die while in service on or after 01-04-2017 and hereby issues the following guidelines for the purpose in continuation of this Department's O.M. No. PPG(P) 292/2017/1 dated 31-10-2017:-

#### 1. CFP to AIS Officers borne on Assam Cadre covered by All India Services (DCRB) Rules, 1958 :-

- So far as the AIS officers borne on Assam Cadre are concerned, if any such officer dies in harness, the benefit
  of the CFP Scheme to the family of the deceased AIS officer shall be applicable till the date of deemed
  superannuation of the concerned deceased AIS officer.
- ii. For payment of CFP to the family of such officer, Govt. of India shall bear the cost equal to the family pension as admissible as per Rule 22 of the All India Services (DCRB) Rules, 1958 as amended and the remaining portion shalf be borne by the State Govt. of Assam till the deemed superannuation of the deceased AIS officer. Thereafter, normal family pension to the family shall be regulated as per provisions of the All India Services (DCRB) Rules, 1958.

#### 2. CFP to AIS Officers borne on Assam Cadre covered by New Pension Scheme :-

AIS officers borne on Assam Cadre, who were appointed on or after 01-01-2004, are not covered by the AIS (DCRB) Rules, 1958. They come under the Contributory Pension Scheme. However, as per provision / procedure prescribed in DOP&PW's O.M No. 38/41/06/P&PW (A) dated 05-05-2009, the family of a deceased AIS officer may avail benefits under old pension scheme. As such, in case of death of any such AIS officer in harness his family also shall be entitled to CFP on condition that the Government of India shall bear amount of family pension upto deemed superannuation of the deceased AIS officer. The remaining portion will be borne by State Government. After deemed superannuation, family pension to family shall be regulated as per provisions of the relevant Pension Rules of the Govt. of India.

This is issued with the concurrence of the Finance (Estt.-A) Department, Government of Assam as conveyed vide their U.O No. 656/21 Dated 04-12-2021.
