- She will be covered under the "New Defined Contribution Pension Scheme" as per Finance (Budget) Department O. M. No. BW.7/2008/Pt/40 dated 06/10/2009 and the Assam Service (Pension) Rules, 1969 shall not be applicable.
- 2. There shall be no distinction between a candidate appointed to Assam Police Service by the Assam Public Service Commission through direct recruitment and a candidate appointed under Rule 5.(I) (c) (ii) of the Assam Police Service Rules, 1966.
