And whereas Section 30(1) of the Act provides for 36 (thirty six) constituencies in the Council Area for electing members to the General Council;

And whereas Section 30(2) of the Act provides that the Government shall determine the territorial limits of the constituencies into which the Council Area shall be delimited for the purpose of election of members to the General Council;

And whereas Section 42 of the Act provides that the Government may designate any officer or authority to determine the territorial limits of the above said constituencies;

And whereas Section 46 of the Act empowers the Government to issue instructions from time to time for the purpose of implementation of the provisions of the Act;

Now therefore, the Governor of Assam is pleased to order that Smti. Binita Pegu, IAS, Secretary to the Govt. of Assam, Department of Tribal Affairs (Plain) shall be the Designated Officer to determine the territorial limits of the 36 (thirty six) constituencies for the General Council of the Bodo Kachari Welfare Autonomous Council in accordance with the provisions of the Act;

And the Governor of Assam is further pleased to order that the Designated Officer shall publish draft Delimitation Order, invite claims, comments, views and objections from political parties, groups and individuals, carry out necessary hearings and take other necessary actions as may be required for the purpose and complete the whole exercise within a period of 4 (four) months from the date of issue of this notification.

- 1) Whereas, the Assam State Cabinet in its meeting held on 6th September, 2022 had notified the delegation of financial powers to various levels to the Engineers at different levels as defined below:

Sl.No.	Designation	Extent of Power
1	Executive Engineer	Schemes be awarded individually or in packages. If awarded in packages, the size of such package should not exceed Rs.1.5 cr.
2	Superintending Engineer	Schemes may be awarded in packages, the size of such package should not exceed Rs.5 cr.
3	Additional Chief Engineer	Schemes may be awarded in packages and the size of such package should not exceed Rs.7 cr.
4	Chief Engineer	Schemes may be awarded in packages which are more than Rs.7 Cr. with the approval of the Hon'ble Minister, PHED.

- 2) Whereas, as per the original Cabinet Memorandum based on which the notification No.PHED.296/2022/25 Dated: Dispur, the 14th September, 2022 was issued quotes "As the award of works are predominantly in the nature of a Rate Contract which was derived on the basis of lowest item wise rates through RFP, the Divisions, Circles, Zones and the Mission Directorate will award works among the eligible empanelled contractors on the basis of their past performance in JJM indicated by the Scoring Matrix (for the existing contractors) and their prior experience in other sectors (for new contractors) with the approval of the Government. The detailed modalities of the same will be worked out by the PHE Department.

The proposed new guideline with regards to the Delegation of Financial Powers described above shall uniformly apply to all areas, including the Sixth Schedule Areas."

- 3) Whereas, the Chief Engineer (PHE), Water, Assam vide letter No. PHE-7/JJM/PB/2022-23/Pt/T/22715 dated: 22nd December, 2022 had written to the Government seeking clarity on whether approval from Government is to be obtained during the work allotment process from the different awarding authorities of the department and the necessary framework to be followed regarding the same.
- 4) Whereas, the matter was examined by the Government and it is hereby clarified that as per the Cabinet Memorandum the actual award of work packages to eligible empanelled Contractors is to be done by the concerned Engineer at their level as per their approved powers, on the basis of the SOP which had already been approved by the Government and no reference to the Government in this regard is required.

The DLCC will undertake construction of Community Halls (Sabha Ghar) as may be allotted by the Director, Welfare of Scheduled Castes & Backward Classes (WSC&BC). Fund for the same will be released by the Director, WSC&BC to the DLCC.

Functions of District Level Construction Committee:

1. The Member Secretary will convene the meeting of the District Level Construction Committee in consultation with the Chairperson.
2. The Member Secretary will get a bank account opened in the name of the DLCC to be operated jointly by the Chairperson and the Member Secretary.
3. The Member Secretary shall obtain the list of Community Halls (Sabha Ghar) to be constructed and the model plan & estimate of the same as approved by the Director, WSC&BC and place before the DLCC. The Member Secretary shall, before starting the work, ensure that proper land is available for the scheme. In case of any dispute, the same shall be brought to the notice of the Director WSC&BC for further necessary action.
4. The DLCC will undertake the construction work of the Community Halls (Sabha Ghar) as per model plan & estimate. The relevant particulars of the works should be displayed at the work site.
5. The Deputy Commissioner will use convergence with other schemes like MGNREGA etc, wherever permissible, for additional items not covered in the model plan & estimate.
6. After completion, the DLCC will hand over the asset to community organization or PRI or other bodies for proper maintenance of the asset.
7. The DLCC will follow all financial and other instructions as applicable.
8. The Member Secretary shall maintain all records.

Whereas Smti. Monurama Das, District Sports Officer, Golaghat was placed under suspension vide Notification Memo No. SYW,. 86/2016/Pt/6-A Dated 13th September, 2019 w.e.f. 4/9/2019 under Rule 6 (2) of Assam Services (Discipline & Appeal) Rules, 1964; and

Whereas Departmental Proceedings were drawn up against Smti. Monurama Das, District Sports Officer (Under Suspension) vide Letter No. SYW.86/2016/Pt/14 Dated 24th October, 2019; and

Whereas Smti. Monurama Das, had furnished her statement of defence vide her letter dated 6/3/2020 and stated that she was arrested in a false case and was ready to face trial in Golaghat P S Case No. 891/19 under section 7 of the P.C. Act.

Whereas, having not been satisfied with the written statement of defence submitted by Smti. Monurama Das, and after careful consideration of all the aspects, the Govt. decided to enquire into the allegations and thereafter appointed Shri Ranuj Borkotoky, ACS, Joint Secretary to the Govt. of Assam, Sports & Youth Welfare Department as Inquiring Officer and Smti. disqualification for future employment' under Rule 7(vii) of the Assam Services (Discipline and Appeal) Rules, 1964, upon Smti. Monurama Das, District Sports Officer (Under Suspension).

SUBJECT :- Timely publication of Government Notifications and other important matters in the weekly Official Gazette.

I am directed to say that it has come to the notice of Government that important notification having bearing on statutes and matters of immediate public interest are sometimes published in the Official Gazette on date much later than prescribed. Government have decided, therefore, to introduce the following system with immediate effect, which must be strictly adhered to in sending notice to the Assam Government Press for publication in the Official Gazette.

1. In the first instance, it has to be noted that the printing of the weekly Gazette must be completed by the end of every Tuesday so that it may be duly published on every Wednesday.

2. Every notification and every other matter which is required to be printed and published in a particular issue of the Official Gazette must, therefore, reach the Director, Assam Government Press on the Monday of the week preceding the week in which it is required to be published. If this is not done it is infructuous requesting the Director, Assam Government Press to publish such notification or other matter in the next issue of the Gazette, the expression usually inserted in all endorsements made to the Director.

3.
