And whereas, Gutkha, Pan Masala, or any chewing material etc (by whatsoever name) containing tobacco and/ or nicotine in an article of food in which tobacco and/ or nicotine are seen to be used as ingredients.

And whereas, it is expedient to prohibit the manufacture, storage, sale, transportation, display or distribution of above mentioned items containing tobacco and/ or nicotine in the state of Assam being food products in which tobacco and/ or nicotine are being used as ingredients.

Now, therefore, in pursuance of Regulation 2.3.4 of the Food Safety and Standards (Prohibition and Restrictions on Sales) Regulation. 2011, the manufacture, storage, transportation, display, distribution or sale of Gutkha, Pan Masala, or any chewing material etc (by whatsoever name) containing tobacco and/ or nicotine as ingredients available in the market, are hereby prohibited in the state of Assam for a period of 1(one) year under Clause (a) of Sub-Section 2 of Section 30 of Food Safety and Standards Act, 2006 in the interest of public health with immediate effect.
