The duties and functions of the State Council shall include:-

- Advising the State Government on all matters concerning the scheme and its implementation in the State.

- g) Any other duty or function as may be assigned to it by the Central Council or the State Government.

The terms and conditions of the State Council:-

- (i) The Chairperson and members or the State council may be appointed and the time, place and procedure of the meetings (including the quorum at such meetings) of the State Council shall be such as may be prescribed by the State Government.
- (ii) The Council shall perform the duties and discharge the functions assigned to it under section 12 (3) of the Act.
- (iii) The State Council may, subject to such control and directions, authorize the Member-Secretary to deal with such financial and administrative matters for its day-to-day functioning.
- (iv) The State Council shall lay down the systems and procedures for maintenance of its accounts and other records.
