Terms of office:

The terms of references of the Sub Divisional OBC Development Board, Tinsukia are as follows:

- 1) To identify the scheme for development having relevance to the OBC population in the OBC areas and send the same for consideration by the State Govt.
- 2) To approve the list of beneficiaries, areas and institutions to be benefited under the OBC welfare scheme.
- 3) To ensure progress of implementation and proper utilization of schemes/ grants of the OBC schemes in the OBC Development areas.
- 4) To review the OBC schemes and to give suggestions on the same to the State Govt.
- 5) Any other matters that may be assigned to the Board by the Advisory Council for welfare of OBC and also by the Govt. of Assam.
- 6) Implementation and monitoring of scheme undertaken by the Assam State Development Corporation for OBC Ltd. for OBC at the Sub Divisional Level.
- 7) The Board shall seat for at least 3 (three) times in a financial year.
- 8) The Board will monitor the implementation of schemes and report to the Govt. through the SDWO concerned.
- 9) The maximum tenure of the Board is 3 (three) years from the date of issue of the notification.
