Division vide his letter No. SD/CON-74-496 dtd. 14/05/2020 informed that an intimation letter had been received from Shri Arun Ch. Bora, J.E. under Nazira W.R. Sub- Division that Sri Santanu Kumar Bora, AEE, Nazira W.R. Division Physically assaulted him. In his letter he has informed that on 13th May, 2020, Sri Santanu Kr. Bora, AEE entered in his room at Water Resource rest house, Simaluguri in drunken state and started hurting him. He also inflicted woundes by hand and with a knife to Sri Arun Ch. Bora. Both the officers got injured in the incident and Shri Santanu Kumar Bora, AEE had been referred to Assam Medical College Hospital, Dibrugarh (AMCH). Later Sri Arun Ch. Bora was arrested and his daughter Smti Kankana Bora Bharali lodge FIR at Simaluguri Police Station and a case was registered against Shri Santanu Kumar Bora, the then Assistant Executive Engineer, Nazira W.R. Sub-Division bearing No.75/2020; and

Whereas the Department requested the Superintendent Engineer Sivsagar W.R. Circle to conduct the preliminary enquiry of the matter and furnish a detail report on the matter vide letter No._WR (CON) 8/2020/8 dated 12/06/2020. Accordingly, the Superintendent Engineer Sivsagar W.R. Circle submitted his enquiry report vide letter No.SES/CON-20/SIV/2020/394 dated 27/07/2020; and

Whereas Departmental Proceeding was drawn up against Shri Santanu Kumar Bora, Assistant Executive Engineer, Sivsagar W.R. Circle (the then Assistant Executive Engineer, Nazira W.R. Sub-Division) vide Show Cause Notice No. WR (CON) 8/2020/50 dated 29-09-2020 for involved in physical assault with Sri Arun Ch. Bora, JE, which is unbecoming of a Government Servant and amounts to violation of Rule 3(1)(i) & Rule 3(1)(iii) of Assam Civil Service (Conduct) Rules,1965; and

Whereas Shri Santanu Kumar Bora, the then Assistant Executive Engineer, Nazira W.R. Sub-Division vide his representation No. Nil dated 20-11-2020 submitted written statement where he denied the charges leveled against him; and

Whereas Water Resources Department decided to conduct an enquiry on the matter by appointing I.O. & P.O.
