E-112866/205.- Whereas, since many of the Transport Department services have been made contactless, now a citizen does not need to visit the DTO office to apply for/avail these services. This has not only brought convenience and transparency but also results in saving of mandays and expenditure which would have happened otherwise if one has to visit the DTO office twice or thrice to apply for and avail any of these services. Even there is no limitation of time now as one can apply online at any time; these services can also be availed at the nearest Common Service Centre (CSC). A robust grievance redressal mechanism is also put in place so that any problem faced by any applicant in availing these services is resolved through electronic mode of email, whatsapp and social media.

And whereas, the State Govt. has delegated the power of registration authority to automobile dealers for registration of fully built transport and non-transport vehicles and also authorized them to print and deliver the registration certificate at the time of sale of vehicle.

And whereas, as per Rule 32 and Rule 81 of the Central Motor Vehicles Rules 1989, as amended, read with Section 28, 38 and 65 of the Motor Vehicle Act 1988, the State Govt. may levy additional fee for use of technology and automation to provide value added services.

Now therefore, in exercise of the power conferred on the State Government by Rule 32 and Rule 81 of the Central Motor Vehicle Rules 1989, as amended, read with Section 28, 38 and 65 of the Motor Vehicle Act, 1988, the Governor of Assam is pleased to levy additional fee for the following contactless value added services, in addition to the fees, as specified in the tables contained in Rule 32 and Rule 81 of the Central Motor Vehicle Rules 1989:
