NOTIFICATION

The 1st March, 2024

No. PLA-33/2008/445.- In exercise of the power conferred by sub-section (1) of Section (9) of the "The Manoeuvres Field Firing and Artillery Practice Act, 1938" (Act 5 of 1938), the Governor of Assam is pleased to define the areas in the schedule below in the **170 Bn. BSF at Dholchera Grant in Cachar district** as the area within which field firing and artillery practice may be authorized for a period of 5 (five) years w.e.f the date of issue of this Notification, provided that

i. The boundary wall of 170 Bn. BSF has been completed on all sides by brick wall on the top of which consorting wire has been fixed.

ii. The safety precautions should be ascertained at the firing range before, during and after firing to avoid accidental casualties as below which are illustrative but not exhaustive:

BEFORE FIRING

(a) Local population around the firing range is informed through public announcement system/police representative regarding the next day firing schedule with a request not to approach the range area during the firing period.

(b) Local police representative(s) remain present at the firing range during the conduct of firing.

(c) Sentries are deployed at all the approach routes of the firing range in red shirts to enable them to be prominently visible with Radio and Mobile communication on the day of firing.

(d) Danger flags (red flags) are hoisted at the stop butt.

(e) Siren is blown to caution the local population regarding the beginning of firing.

(f) The firers also shout in unison regarding the fire.

(g) The weapons are inspected by the armourer to avoid any accident before the conduct of fire.

DURING FIRING

- (a) Detailed range drill as per the SOP is allowed for conduct of fire under the supervision of a Gazetted Officer.
- (b) Firers are trained soldiers and well conversant with fire practices.

AFTER FIRING

- (a) Again the siren is blown to make the local population aware of completion of fire.
- (b) Weapons are again inspected by the armourer to check any damages.
- (c) All empty cases are recollected and deposited in the Kote.
- (d) Any damage to man/material is checked under the supervision of a Gazetted Officer.
