- f. Prepare bottomry and respondentia bonds, charter parties and other mercantile documents.
- g. Prepare attest or authenticate any instrument intend to take effect in any country or place outside India in such form and language as may conform to the law of the place where such deed is entitled to operate.
- h. Translate, and verify the the translation of, any document from, one language into another.
- i. Act as a Commissioner to record evidence in any Civil or Criminal trial if so directed by any Court or Authority.
- j. Act as an arbitrator, mediator or conciliator, if so required.
- k. Any other act which may be prescribed.

In addition, they may undertake functions prescribed under Rule-11(8) of the Notaries Rules 1956 as amended. All such notarial acts shall be done under the signature and official seal of the Notary concerned and they are entitled to charge for notarial works only such fees, not exceeding the rates prescribed under Rule-10 of the Notaries Rules,1956 as amended.
