Whereas, Shri Saibar Rahman, ACS submitted reply to the Show Cause Notice dated 8th November, 2021 on 23rd November, 2022 which was examined by the Disciplinary Authority and found it not to be satisfactory and decided to hold an enquiry into the charges framed against him by appointing an Inquiring Authority;

Whereas, an Inquiring Authority has been appointed vide order dated 30th January, 2023 and the report of the Inquiring Authority is awaited;

Whereas a Review Committee has been constituted to review the case of suspension and after examining all the records of the cases against Shri Saibar Rahman, ACS and considering the seriousness of the charges which involve moral turpitude, corruption and misuse of official power for personal gain, the Review Committee has recommended for extension of his suspension period. The focus of the Aspirational Block Programme is on the thematic areas of Health and Nutrition, Education, Agriculture and Water Resources, Basic Infrastructure, Social Development and Financial Inclusion. The relevant Departments therefore are Health and Family Welfare, Women & Child Development, Education, Agriculture, Irrigation, P&RD Department.

The following arrangements are being proposed for implementation of the Aspirational Block Programme -

1. One ADC from each district of the 20 backward development blocks is proposed to be nominated as nodal officer for the Aspirational Block Programme.
2. A Block Level Implementation cum Monitoring Committee for the Aspirational Block Programme may be constituted in each 20 Aspirational Blocks. The proposed composition of the committee is :

Chairperson : Additional Deputy Commissioner

- Member Secy. : BDO
- Members : District Heads of Health, Women and Child Development, Education, Agriculture,
- Member : Irrigation, P&RD Department.
- One MIS Operator from the Block to be selected by BDO for regularly uploading the data.

Where there is more than one backward block in the district then same ADC will be act as Chairperson of all the blocks, however other member of the committee will vary accordingly.

This committee will meet fortnightly to review implementation progress.

3. A District Level Implementation Committee of the concerned districts of the Aspirational Blocks may be constituted. The proposed composition of this committee is:

- Chairperson : Deputy Commissioner
- Member Secy. : ADC (Chairman of Block Committee)
- Member : District Heads of Health, Women and Child Development, Education, Agriculture, Irrigation, P&RD Department.

In Sixth Scheduled Areas, the District Level Implementation Committee will have the following composition.

- Chairperson : Secretary, Rural Development
- Member Secy. : ADC (Chairman of Block Committee)
- Member : District Heads of Health, Women and Child Development, Education, Agriculture, Irrigation, P&RD Department.

This committee will monitor the progress on monthly basis.

4. A District Level Advisory Committee of the concerned districts of the Aspirational Blocks may be constituted. The proposed composition of this committee is:

- Chairperson : Guardian Minister of the district
- Vice Chairperson : Deputy Commissioner
- Member Secy. : CEO, Zilla :Parishad/PD DRDA
- Members : Hon'ble MLAs of the districts
- Members : District Heads of Health, Women and Child Development, Education, Agriculture, Irrigation, P&RD Department and ADC (Chairman of Block Level Committee).

This Committee will oversee the overall progress in every sector as envisaged in the programme and give necessary guidance.
