Assistant Engineer by issuing Show Cause notice vide letter No.WR(CON)4/2011/45 dated 27/04/2012. Department also gave FIR to IGP (CID) Assam vide letter No.WR(CON) 4/2011/33 dtd 19/04/2011; and

Whereas, the disciplinary authority after a stipulated time from the date of issue of show cause notice vide letter No.WR(CON)4/2011/45 dtd 27/04/2012 decided to appoint an Inquiry Officer as per rule 9(4) of Assam Services (Discipline & Appeal) Rule 1964. Accordingly, Shri Ananta Kr. Barua, the then Additional Chief Engineer (i/c), Dima Hasao W.R. Zone was appointed as Inquiry Officer vide Notification WR(CON)4/2011/141 dtd 30/08/2012; and

Whereas, the reply to the show cause notice submitted by Sri Dinesh Chandra Sarma vide his letter No. nil dtd. 03/09/2012 and denied the charges leveled against him; and

Whereas, the Inquiry Officer submitted his report vide letter No. RRS/CON-I07/2012/9 dtd. 15/12/2012 in respect of Shri Dinesh Chandra Sarma, Retd. Assistant Engineer. The Delinquent Officer was found guilty of financial irregularities. The Inquiry Officer in the finding mentioned that-

"1. It has been proved from the records of Bank statements and facts that the Delinquent Officer during the period from 30/05/2007 to 29/03/2008 received the ceilings of Rs. 93.00 Lakhs released by the N.C. Hills Autonomous Council (in four instalments). It is also evident from the statement of the seizure list & Cheque Books etc. seized by the NIA authorities, (presently lying under By S.P, CID Hqrs; Ulubari, Ghy-3, that the Delinquent Officer had disbursed on amount of Rs. 92, 13.338.00 out of the Rs. 93.00 lakhs ceiling received by him (Rs. 86,662.00 was the closing balance left in bank deposits.) during his incumbency as Executive Engineer & DDO of the Haflong W.R. Division. The Delinquent Officer had made these payments vide cheque Book no. CAB $\frac{00}{221}$ & CAB $\frac{00}{084}$. It is observed from the records of the CID seizure list that the Delinquent Officer cancelled about 87 Cheques while disbursing the ceilings.

These payments/disbursing of the ceiling amounts by the Delinquent Officer, were made (excepting Rs 10.00 lakhs) were made without any supporting bills & vouchers & Cash Book entries, nor against any sanctioned & approved schemes. Only, the first ceiling of Rs. 10.00 lakhs was made against a sanctioned schemes, but in the case too, the bills were not passed, although he did submit the accounts to the A.G. etc. authorities with Cash Book entries.

The Delinquent Officer therefore made a faulty transactions of Govt. propriety of the amount of Rs. 92,13,338.00- Rs. 10,00,000.00 = Rs. 82,13,338.00, against which there are no supporting Cash Book entries, bill & vouchers of any sanctioned & approved scheme against which he disbursed the amount."

The Inquiry Officer recorded his Comments & Conclusions as mentioned below- "COMMENTS & CONCLUSIONS:

Therefore on the basis of the first and second hearings, also from the records, evidences, depositions and statements submitted by the Presenting Officer, Witness & Delinquent Officer (all documents, statements and records with their signatures are enclosed herewith), this enquiry without any prejudices, under the provisions of the Assam civil Services Conduct Rules, 1965, Assam Services (Discipline & Appeal) Rules, 1964, pronounces the Delinquent Officer guilty of Financial irregularities under the charges as laid down vide WR(CON) 4/2011/45, dated 27th April, 2012 and RRS/CON-107/2012/5, dated 1st October, 2012.

The enquiry therefore subject to the report of the NIA/CID and the production of the seized documents to this department to conclude this proceeding with recommendations for filing of FIR under the relevant Police station for the criminal offence for law to take its own course, or proportionate punishment in the form

of recovery, or withheld of pension benefits whichever the disciplinary and appointing authority deems fit for consideration."

Whereas, enquiry report was submitted to Sri Dinesh Chandra Sarma, Retd. Assistant Engineer and requested him to submit his representation (if he wish to) on the enquiry report within 7 days; and

Whereas, Department did not received any representation from the Delinquent Officer Sri Dinesh Chandra Sarma, Retd. Assistant Engineer. Further, it was recommended for filing of FIR under the relevant Police station for the criminal offence for law to take its own course, or proportionate punishment in the form of recovery, or withheld of pension benefits whichever the disciplinary authority deems fit for consideration. However, it would not be possible to recover the huge amount of Rs 82,13,338.00 from Shri Dinesh Chandra Sarma, since he has already retired from service on attaining the age of superannuation on 31/12/2010. Hence it is proposed to withhold his pensionery benefits under Rule, 21 of the Assam Services Pension Rules, 1969 as amended for the life time; and

Whereas, the Water Resources Department sought for the views of Assam Public Service Commission regarding the proposed penalty against the delinquent officer and the Commission vide their U/O No. 1372 dtd. 08/02/2018 agrees to the proposed penalty against the delinquent officer Sri Dinesh Chandra Sarma, Retd. Assistant Engineer; and

Whereas, views of Judicial Department, Pension and Public Grievances Department and Finance (Establishment -A) Department were also consulted in this regard. Judicial Department vide their U/O No.63/2019 dtd.08/05/2019, Finance (Establishment-A) Department vide their U/O No. FE No.710/2019 dtd.21/11/2019 and PPG Department vide their U/O No.PPG(P)565/2019 dtd.24/09/2020 agreed to the propose penalty; and

Whereas, Hon'ble Chief Minister of Assam has also agreed to the propose penalty.

Considering all the facts of the matter stated herein above, the Governor of Assam is pleased to impose a penalty of withholding of pensionary benefits for life time to Sri Dinesh Chandra Sarma, Retd. Assistant Engineer under Rule 21 of Pension Rules.

With the above order the proceeding is concluded.
