The 18th February, 2021

**No. FRE.16/2001/Pt/370.**- Whereas, a departmental proceeding was drawn up against Md. Anisur Rahman, AFS, the then Range Officer, Udharbond Range under Cachar Division, and a show cause notice was issued vide letter No. FRE.16/2001/Pt/252, dated 24<sup>th</sup> March, 2010 along with Statement of Allegation of charges, List of Exhibits, to Shri Md. Anisur Rahman, in respect of the following charges:

1. Charge No.1 : Gross indiscipline, insub-ordination and doubtful integrity.
2. Charge No.2 : Misuse of power for wrongful personal gains,
3. Charge No.3 : Breach of trust and unbecoming of a Government servant and misuse of power for wrongful personal gains,
4. Disobedience to the superior authority, negligence of Government duty and loss of revenue to the Govt. Exchequer,
5. Submission of false diaries, misuse of power causing harassment to the top officers engaged for the developmental works of the state and of doubtful integrity.

The defence statement submitted by the delinquent officer has been received in the Department on 05-11-2012.

**Whereas**, on being not satisfied with the defence statement submitted by the Delinquent Officer, the Environment & Forests Department instituted a Departmental enquiry by appointment of an Inquiry officer Smti Purabi Sonowal, IAS, Registrar, Co-operative Societies (State Enquiry Officer) Assam vide letter No. FRE.16/2001/Pt/270, dated 15<sup>th</sup> May, 2014 and Presenting Officer Shri Prabhakar Das, DFO, Cachar Division, Silchar, vide Letter No. FRE.16/2001/Pt/270-A, dated 15<sup>th</sup> May, 2014.

**Whereas**, the enquiry officer, submitted her enquiry report and findings vide her letter No. ABE.16/2014/128, dated 24<sup>th</sup> April, 2015. The enquiry report was forwarded to Delinquent officer for his representation vide letter FRE.16/2001/Pt/285, dated 26<sup>th</sup> June 2015. The written representation was submitted by the delinquent officer on 27-08-2015, who has categorically expressed that he is not satisfied with the enquiry.

**Whereas** a re-enquiry was initiated upon advice of Judicial Department vide their endt. dated 11.01.2017, by Inquiry Officer Shri Prantosh Roy, IFS, Addl.PCCF (F.C.Act), O/o the PCCF & HoFF, and Presenting officer Shri S.I.Choudhury, IFS, DFO, Cachar Division.

**Whereas**, the enquiry officer, submitted his enquiry report and findings vide his letter No.PG.531/FR, dated 11<sup>th</sup> June, 2020. The enquiry report was forwarded to Delinquent officer for his representation vide letter FRE.16/2001/Pt/355, dated 25<sup>th</sup> June 2020. The written representation was submitted by the delinquent officer on 27-08-2020.

Therefore, upon perusal of all charges framed, connected papers, documents etc. and hearing of the person concerned, the undersigned arrived upon conclusion which was very unambiguously stated in the enquiry report, reproduced as below-

1. The charge of "Gross indiscipline, insub-ordination and doubtful integrity" is proved.
2. The charge of "Misuse of power for wrongful personal gain" is partially proved.
3. The charge of "Breach of trust and unbecoming of a Government servant and misuse of power for wrongful personal gains," is not proved.
4. The charge of "Disobedience to the superior authority, negligence of Government duty and loss of revenue to the Govt. Exchequer" is not proved.
5. The charge of "Submission of false diaries, misuse of power causing harassment to the top officers engaged for the developmental works of the state and of doubtful integrity", is partially proved.

**After** careful examination of the findings of the Inquiry Officer, it reveals that out of the 5(Five) charges, only charges No.1 is proved, No.2 and No.3 is partially proved while the other charge could not be established by the Inquiry Officer. Therefore, the Governor of Assam in exercise of power conferred by the Rule 7 of the Assam Services (Discipline and Appeal) Rules, 1964 is pleased to conclude the proceeding drawn up against Md. Anisur Rahman, AFS, the then Range Officer, Udharbond Range under Cachar Division, with a minor penalty of "withholding 2(two) increments with cumulative effect" under Rule 7(ii) of the Assam Services (Discipline and Appeal) Rules, 1964.
