**No. 224064/1.-** In pursuance modification of this Deptt.'s Notification No.PDA.295/2021/140 dtd. 26th July, 2022 Whereas, Sri Bhupati Barman, the then Jr. Engineer of Dhubri Zilla Parishad (presently posted at Goalpara Zilla Parishad) was placed under suspension vide office order No. PDA.355/2016/ Vol./204, dated-16th March, 2018 for irregularities in payment of bill to the contractors in connection with the work of external and internal electrification and water supply & sanitation in the Office Building cum Guest House in Dhubri Zilla Parishad and multipurpose Hall at Agamani Anchalik Panchayat under the provision of the Assam Services (Discipline & Appeal) Rule 1964.

Whereas Departmental Proceeding was drawn up against Shri Bhupati Barman, the then Junior Engineer of Dhubri Zilla Parishad (presently working at Goalpara Zilla Parishad) by issuing show cause notice vide letter No.PDA.355/2016/V 01/205, dated-3rd April, 2018 on the charges of irregular payment of bill certified by Shri Bhupati Barman, Junior Engineer amounting to Rs.7,22,814.00 (Rupees seven lakh twenty two thousand eight hundred fourteen) only against the work of external and Internal Electrification work, and Water Supply & Sanitation work for the project "Construction of Multipurpose Hall at Agomani A.P and Zilla Parishad Office Building-cum-Guest House, Dhubri for the year 2011-12" first in of favour of Sri Samsul Islam, Contractor and latter the same bill was also submitted and certified by the delinquent Officer subsequently in favour of Sri Paban Kumar Bagaria, Contractor, which caused a title dispute between the contractors and the matter was discussed in the meeting of the Committee on Petitions, Assam Legislative Assembly held on 7th December, 2017 and 18th June, 2018.

and

Whereas the Delinquent Officer Sri Bhupati Barman, Junior Engineer had submitted his written reply in defence vide his letter dtd.24th May, 2018 against the show cause notice, wherein Delinquent Officer denied all the charges levelled against him.

Whereas after careful examination of all the records of the Delinquent Officer available in the file, the Disciplinary Authority is not being satisfied with the written statement submitted by the Delinquent Officer and decided to go for enquiry by appointing an Enquiry Officer under the provision of Rule 9(4) & (5) of the Assam Services (Discipline & Appeal) Rules, 1964.

Accordingly, the Governor of Assam is pleased to appoint the State Enquiry Officer vide Notification No.PDA.295/2012/22 dated 2nd August, 2018 to make an enquiry into the charges levelled against Shri Bhupati Barman, the then Junior Engineer of Dhubri Zilla Parishad (presently working at Goalpara Zilla Parishad) and to submit his findings/report to this Department within a period of 1 (one) month positively.

Whereas, subsistence allowance was granted vide letter No.PDA.295/2012/17 dated 18th August, 2018 & No.PDA.295/2012/24 dated-18th August, 2018.

Whereas, Shri Bhupati Barman, the then Junior Engineer of Dhubri Zilla Parishad (now working at Goalpara Zilla Parishad) was reinstated in service and posted at Goalpara Zilla Parishad vide Notification No.PDA.295/2012/28 dated 7th March, 2019.

Whereas, the State Enquiry Officer has submitted the Enquiry Report vide letter

No.ABE.13/2018/54 dated 9th September, 2021 in respect of the Departmental Proceeding drawn up against Shri Bhupati Barman, the then Junior Engineer of Dhubri Zilla Parishad (now working at Goalpara Zilla Parishad) and found gross fraudulence, dereliction and negligence of allotted duty, insincerity and gross violence of government procedure on the part of the Delinquent Officer in this matter.

Whereas, in view of the facts stated above, the Governor of Assam is pleased to drop the Departmental Proceeding drawn up against Sri Bhupati Barman, the then Jr. Engineer of Dhubri Zilla Parishad and presently posted as Junior Engineer Goalpara Zilla Parishad which will meet the end of justice and also please to "award withholding of 2(two) increments for two years with permanent effect" from the date of passing of this order/with immediate effect in respect of Sri Bhupati Barman, Junior Engineer of Goalpara Zilla Parishad.

Accordingly, the Departmental Proceeding is finally disposed of.

[Attention of all officers ending matters for publication in the Assam Gazette is drawn to the following Government circular with the request that instructions contained therein may kindly be strictly adhered the orders to avoid delay in publication of Notification in the Assam Gazette:-]

**Lett. No. PG. 22/70/P-II/1,** dated Shillong, the 2nd June, 1970 from the Chief Secretary to the Government of Assam to all Administrative Departments, all Head of Departments, All Deputy Commissioners and Sub-Divisional Officers.

**SUBJECT**:- Timely publication of Government Notifications and other important matters in the weekly Official Gazette.

I am directed to say that it has come to the notice of Government that important notification having bearing on statutes and matters of immediate public interest are sometimes published in the Official Gazette on date much later than prescribed. Government have decided, therefore, to introduce the following system with immediate effect, which must be strictly adhered to in sending notice to the Assam Government Press for publication in the Official Gazette.

1. In the first instance, it has to be noted that the printing of the weekly Gazette must be completed by the end of every Tuesday so that it may be duly published on every Wednesday.

- 2. Every notification and every other matter which is required to be printed and published in a particular issue of the Official Gazette must, therefore, reach the Director, Assam Government Press on the Monday of the week preceding the week in which it is required to be published. If this is not done it is infructuous requesting the Director, Assam Government Press to publish such notification or other matter in the next issue of the Gazette, the expression usually inserted in all endorsements made to the Director.
- 3. Wherever it is necessary to print and publish a notification on a specified date (excluding such Notification or communicate as are to be published in Gazette extraordinary) clear instruction of that effect must be given to the Director, Assam Government Press, both on the body of such notification within the indication at the top in the red ink and is a separate covering.
- 4. To achieve the objective in papers 2 and 3, it is essential that proper discretion should be exercised by the concerned officers in the Department or office and all matters for publication in the Gazette should scrutinised and sent to the Press after careful application.
- 5. As for publication of any matters in a Gazette, Extraordinary, the existing procedure whereby the prior approval of the General Administration Department is to be obtained will continue.

I am to request you to acknowledge the receipt of this letter and confirmed that the instructions have been duly voted. If you have suggestion on this behalf they may please be communicated.

#### KAMARUPA ANUSANDHANA SAMITI GAUHATI

The Kamarupa Anusandhana Samiti or the Assam Research Society, Gauhati is the main subject in the carrying on researches in the matter relating to History Archaeology Ethography, etc. It has a library of rare books. Journal/historical and antiquarian subjects. The premises of the Samiti, situated on the southern bank of the Dighali Tank, Gauhati, remains open from 2 p. m. to 5 p. m. on all days except Monday and Gazetted and local holidays or which it remains closed.
