Subject: Engagement of retired police personnel in police stations on contractual assignment.

No. HMA.183/2021/50.- The State Empowered Committee (SEC) constituted for scrutiny and recommendation of the cases of re-employment/re-engagement in its meeting held on 7th August, 2021 declared the following:

"Principal Secretary, Home Department highlighted the recent announcement of Hon'ble Chief Minister, Assam regarding engagement of retired police officers in police stations. It was clarified that the decision may be taken by Assam Police Headquarters in the line of the Personnel (A) Department's O.M No.AAP.98/2017/30 dated 18th July, 2018 and then the approval of the Hon'ble Chief Minister through the Chief Secretary may be taken."

In view of the above decision of the State Empowered Committee (SEC), it is felt necessary to put in place the following mechanism so that such proposals for re-employment/re-engagement may be processed and disposed of with ease.

- 1. The Assam Police Headquarters will submit proposals for engagement of retired police personnel on contractual basis in the police stations of the State only where there is huge pendency of cases against insufficient manpower requiring timely disposal or where there is justification for engagement of such retired police personnel.
- 2. The basic terms and conditions laid down in the Govt. O.M No.AAP.98/2017/30 dated 18th July, 2018 regarding age, ability, period of contract, remuneration etc. of the retired officer will strictly be adhered to.

- 3. The proposals for re-employment of retired personnel will be submitted with proper justification along with the details of the assignments to be given.
- 4. The proposals for re-employment on contractual basis will include the remuneration to be awarded to the contractual employees. The remuneration may be fixed with the Basic Pay (Pay in the Pay Band+ (plus) Grade Pay) supported by Last Pay Certificate or Last Pay Slip of Accountant General, Assam (minus) Basic Pension supported by PPO issued by Accountant General, Assam + (plus) admissible Dearness Allowance as per provisions of Finance Department's OM No.FEB.154/03/1 dated 7th April, 2004.
- 5. The proposals should reflect the names of the police stations or the offices where an employee is likely to be engaged on re-employment. The Assam Police Headquarters will preferably place the contractual retired employees in police stations or offices in and around their present residence considering the logistics such as stay, transport, communication etc.
- 6. The Assam Police Headquarters will submit proposals for re-employment only in cases where budgetary allocations are available. This will reduce time in awarding remuneration to the re-employed persons as further concurrence of Finance Department will not be necessary.
- 7. Such self-contained proposals will be moved to the Hon'ble Chief Minister, Assam through the Chief Secretary, Assam. The copy of such approval shall be provided to Finance Department and Personnel Department for records.
- 8. Once the approval for re-employment is received from the Government, Assam Police Headquarters will engage the persons in their allotted works and also provide the remuneration to the contractual employees accordingly.
- 9. If any extension is required for such employees, the proposals will be submitted well ahead of time with proper justification along with the details of the assignments to be given.
- 10. The Assam police Headquarters will terminate the officers as and when the targeted work is completed or if the officer fails to deliver as required under the scheme or if the tenure of re-employment is complete, whichever is earlier.

Lett. No. PG. 22/70/P-II/1, dated Shillong, the 2nd June, 1970 from the Chief Secretary to the Government of Assam to all Administrative Departments, all Head of Departments, All Deputy Commissioners and Sub-Divisional Officers.

SUBJECT:- Timely publication of Government Notifications and other important matters in the weekly Official Gazette.

I am directed to say that it has come to the notice of Government that important notification having bearing on statutes and matters of immediate public interest are sometimes published in the Official Gazette on date much later than prescribed. Government have decided, therefore, to introduce the following system with immediate effect, which must be strictly adhered to in sending notice to the Assam Government Press for publication in the Official Gazette.

1. In the first instance, it has to be noted that the printing of the weekly Gazette must be completed by the end of every Tuesday so that it may be duly published on every Wednesday.

- 2. Every notification and every other matter which is required to be printed and published in a particular issue of the Official Gazette must, therefore, reach the Director, Assam Government Press on the Monday of the week preceding the week in which it is required to be published. If this is not done it is infructuous requesting the Director, Assam Government Press to publish such notification or other matter in the next issue of the Gazette, the expression usually inserted in all endorsements made to the Director.
- 3. Wherever it is necessary to print and publish a notification on a specified date (excluding such Notification or communicate as are to be published in Gazette extraordinary) clear instruction of that effect must be given to the Director, Assam Government Press, both on the body of such notification within the indication at the top in the red ink and is a separate covering.
- 4. To achieve the objective in papers 2 and 3, it is essential that proper discretion should be exercised by the concerned officers in the Department or office and all matters for publication in the Gazette should scrutinised and sent to the Press after careful application.
- 5. As for publication of any matters in a Gazette, Extraordinary, the existing procedure whereby the prior approval of the General Administration Department is to be obtained will continue.
